Mr. Smrha noted that both the Chairman and Vice-Chairman were absent and asked if it was the will of the members present to hold the meeting. The answer was in the affirmative, and Mr. Smrha called the meeting to order at 10:10 A. M.

Mr. Smartt moved that Mr. Smrha become acting Vice-Chairman for this meeting. The motion was seconded and approved by both States.

Mr. Smrha remarked that Mr. Paulsen, Mr. Green and Mr. Sparks were not present, but since two representatives each from Kansas and Colorado were present, a quorum existed.

The minutes of the last meeting were discussed at length as to the desirability of approving them without hearing the opinions of Mr. Green and Mr. Sparks, since statements by them were an important part of the meeting. Mr. Bentrup moved that action on the minutes of the October 28, 1958 meeting be deferred until the March meeting. The motion was duly seconded and approved.

Since the Chairman was not present, Mr. Smrha said that his report would have to be deferred.

Mr. Smartt gave the Secretary's report verbally and said that the resolution had been forwarded to Mr. Crawford, as directed, and budget requests had been sent to the Governors of Kansas and Colorado. The Arkansas Valley Ditch Association had requested a copy of the minutes of the last meeting and also wanted a copy of the next Annual Report. The same association transmitted a letter to the Secretary containing a copy of a resolution passed at a meeting October 17, 1958. A copy of this letter and the reply by the Secretary follows:

My dear Sir:

You of course are familiar with the recent movement for creating a permanent pool in John Martin Reservoir, for recreational purposes. Said proposed permanent pool was discussed at length at the October meeting of the Executive Committee of this Association, after which the following statement was released to the press: "At the October meeting of the Executive Committee of the Arkansas Valley Ditch Association, held in La Junta on the 17th, the following resolution was unanimously adopted:

'Careful consideration of the proposed permanent pool at John Martin Reservoir indicates that such a plan is not feasible. In years of water scarcity a pool could not be maintained without injury to the vested rights of water users on the Arkansas River. This Association favors recreational facilities for the Arkansas Valley, but at the same time believes that sportsmen of the area should be prepared to face the ups and downs of water supply as are the other water users in the Valley.'"

Mr. Smartt gave the Treasurer's Annual Report and stated that although he did not have it divided as such, the report for the period of October 28, 1958 to date includes only those vouchers numbered 252 through 257. Mr. Smrha, reporting for the Engineering Committee, said that no meetings of the committee had been held and there was, therefore, no report.

Mr. Bentrup read the report of the Operations Committee as follows:

#### ARKANSAS RIVER COMPACT ADMINISTRATION

# Report of Operations Committee

There was no change in the discharge from the reservoir since our meeting of October 28 which was 650 cfs, where it remained until 10 PM on October 31 when the gates were closed. The amount of water in storage in John Martin Reservoir on April 1, 1958 was 278,828 acre feet, and at the end of this irrigation period the reservoir contained approximately 231,000 acre feet.

The elevation to date is 3838.47 feet with 234,997 acre feet of water in storage.

Carl E. Bentrup Chairman Operations Committee

A motion to accept the Operations Committee report was made by Mr. Smartt. The motion was seconded and passed.

Mr. Bentrup read a letter that had been prepared by Mr. Sparks for the Operations Committee to send to Colonel Reed as follows:

Colonel Albert L. Reed, Dist. Engr., U. S. Corps of Engineers, P. O. Box 1538 Albuquerque, N. M.

Dear Colonel Reed:

Under date of July 12, 1958, I directed a letter to you at the request of the Arkansas River Compact Administration concerning releases from John Martin Reservoir in the event storage in the reservoir reached the top of the conservation pool. By letter dated July 23, 1958, you replied to the Administration to the effect that your office did not deem it advisable to depart from the present operating procedures which, in the event the top of the conservation pool is reached, would require the release of the river in-flow but not to exceed 5000 cubic feet per second.

We are not satisfied that the maximum release of 5000 cubic feet per second should be made at such a time when the reservoir still has a flood control capacity of, say for example, 200,000 acre feet. It appears to us that releases should be graduated in accordance with the available flood control storage. We well realize, however, that your office has conducted an intensive study of all possible conditions which might exist in the Arkansas River. Since no such intensive studies have been conducted by this Administration, we are not prepared to disagree with your conclusions at this time. It is our intention to initiate studies to determine whether or not the present operating principles can be improved upon. It is our opinion that in the event the proposed Trinidad Project is constructed, then such construction would have a significant effect upon the flood control pool required in John Martin Reservoir. Therefore will you please advise us as to whether or not your office is currently considering the revision of the flood pool requirements of John Martin Reservoir in view of the possible construction of the Trinidad Project.

After some discussion Mr. Smartt's motion was seconded and approved directing the Operations Committee to transmit the letter to Colonel Reed as drafted.

Mr. Smrha's suggestion that the report of the Legal and Administrative Committee be deferred until the afternoon session was agreed to by the other members of the Administration.

The election of officers being the next order of business, Mr. Bentrup nominated Mr. Green for Vice-Chairman. The nomination was seconded and Mr. Smartt moved that nominations for Vice-Chairman cease and Mr. Green be declared elected to the post unanimously. The motion was duly seconded and passed.

Mr. Bentrup nominated Mr. Smartt for Secretary. The nomination was seconded and Mr. Jenkin's motion was seconded and passed that nominations be closed for Secretary and Mr. Smartt be unanimously elected Secretary.

Mr. Jenkins nominated Mr. Smartt for Treasurer and the nomination was duly seconded. Mr. Bentrup's motion was seconded and passed to cease nominations and declare Mr. Smartt unanimously elected Treasurer.

Mr. Jenkins moved that the Secretary's salary be the same as for the previous year plus actual expenses. The motion was seconded and passed.

Mr. Jenkins moved that the following committee members and chairmen be named for the coming year:

Administrative and Legal Committee: Logan N. Green (Chairman) David Jenkins

Engineering Committee: R. V. Smrha (Chairman) Felix L. Sparks

Operations Committee: Carl E. Bentrup (Chairman) Hacket Smartt The motion was seconded and approved by Colorado and Kansas.

Mr. Smrha suggested that the meeting recess for lunch.

### Afternoon Session

Mr. Smrha reconvened the meeting at 1:10 P. M. and asked for the report of the Administrative and Legal Committee. Mr. Jenkins then introduced the Annual Report and it was discussed in detail. Mr. Smartt submitted the Treasurer's Annual Report for inclusion in the Annual Report of the Administration and Mr. Bentrup's motion to accept the Treasurer's Annual Report was duly seconded and passed as follows:

#### Gentlemen:

In accordance with your request, an examination has been made of the financial transactions of the Arkansas River Compact Administration for its "Report-Year"-November 1, 1957 to October 31, 1958. The results of the audit are expressed in the attached statement of cash receipts and disbursements, Schedule I, Page No. 4. The remarks which follow are offered as additional information and tend to describe the extent of the audit work performed.

#### General Comments

Schedule I, reflects the beginning balance of cash in bank, revenue assessments received from the States of Colorado and Kansas, expenditures by classification and the ending balance of cash in bank.

As provided for in the budget of the Administration's Meeting of October 26, 1956 and authorized for call in the Minutes of the Meeting of October 22, 1957, funds due from Colorado (60% share) of \$1,800.00 and Kansas (40% share) of \$1,200.00 were received for the budget year ending June 30, 1958 and placed on deposit with the First National Bank in Lamar, Colorado on the respective dates of December 2, 1957 and December 31, 1957. In like manner, per request of the Representatives in their Minutes of the July 8, 1958 Meeting, budget contributions for the year ended June 30, 1959, were received from Colorado and Kansas in the respective amounts of \$1,800.00 and \$1,200.00. According to the Administration's records, Colorado funds were deposited on August 26, 1958, while monies received from Kansas were put in the bank on September 4, 1958.

All disbursements were made by checks drawn on the Administration's account at the First National Bank in Lamar, Colorado. The individual checks were examined for amount, signature, and endorsement. Amounts so expended were substantiated by verification to payees' statements, authorization of payment as evidenced in minutes of the Compacts' meeting, or other supporting documents. Consistent with prior year's practices, the Secretary's salary for the current year of \$1,200.00 has been reduced by the Old-Age and Survivor's Insurance deductions amounting to \$27.00. This figure of \$27.00 together with the Administration's contribution of like amount are shown under the classification of taxes on Schedule I.

Travel expense of the Secretary for the fiscal year ending October 31, 1958 amounted to \$54.32 or 679 miles at \$0.08 per mile.

Payments made to the U. S. Treasurer totaling \$54.00 during the year were accompanied by related returns referring to Old-Age and Survivor's Insurance information on the Secretary.

Cash in bank at October 31, 1958, per Schedule I, amounting to \$4,512.86 was reconciled to the amount directly confirmed by the First National Bank in Lamar, Colorado.

According to the Minutes of the Meeting of July 23, 1957, the budgeted expenditures for the fiscal year ended June 30, 1959 were approved in the amount of \$3,800.00. Of this amount, \$800.00 is to come from an unexpended balance carry over at June 30, 1958, supplemented by an appropriation of \$3,000.00 from the States of Colorado and Kansas in the respective amounts of \$1,800.00 and \$1,200.00. You are reminded, these sums have been called and received and are discussed in detail on page no. 1 of this report. The Administration anticipates, as evidenced in the Meeting of July 8, 1958, budgeted expenditures for the period July 1, 1959 to June 30, 1960 will total some \$5,800.00. Of this figure, \$1,800.00 will come from unexpended funds of the Compact as of June 30, 1959, while the remaining balance of \$4,000.00 will be requested from the States of Colorado and Kansas on a 60%-40% basis.

A discussion ensued on the method used in computing Colorado demands for water at times when there are also demands by Kansas. It was finally suggested that the Operations Committee should make a report at the next meeting to refresh the memories of the other members on how the demands were computed.

Mr. Smartt's motion was seconded and passed to approve and adopt the Annual Report. Mr. Bentrup then moved that the Administration accept the bid of the Peerless Printing Company of Denver of \$634.00 for printing the Annual Report and the By-Laws as amended.

Mr. Smrha recognized Mr. Nevius and welcomed him to the meeting.

Mr. John Martin when asked for a statement concerning the Corps of Engineers, said that the Corps has initiated a preliminary operation study of encroachment into 20,000 acre feet of the flood control pool, but no completion date has been set for the study.

Mr. Wallace Miller said he had no further report to make in behalf of the U. S. Geological Survey other than that found in the Annual Report of the Administration.

Mr. Bentrup's motion was seconded and approved to express the appreciation of the Administration to all who have contributed to completing the Annual Report.

The meeting was adjourned at 2:30 P. M.
