MINUTES OF THE

ARKANSAS RIVER COMPACT ADMINISTRATION SPECIAL TELEPHONIC MEETING

APRIL 15, 1980



A special telephonic meeting was held by the Arkansas River Compact Administration at 9:45 a.m., Mountain Standard time, April 15, 1980. The meeting was called at the request of Colorado member, Mr. William McDonald.

Mr. Frank Cooley, Chairman, called the meeting to order and asked for a roll call. Kansas members, Mr. Guy Gibson, Mr. Carl Bentrup, and Mr. Fred Stoeckly answered "here". Mr. Guy Gibson stated that Mr. Gerry Hilmes, Kansas hydrologist and Mr. Lee Rolf, attorney for Kansas, were with him. Mr. Carl Bentrup indicated that Mr. Howard Corrigan, Kansas Water commissioner, was with him. Colorado members, Mr. William McDonald, Mr. Kent Reyher, and Mr. Leo Idler answered "here". Mr. William McDonald stated that Mr. Duane Helton was with him. Mr. Robert Jesse, Division Engineer for the Arkansas River in Colorado and Assistant Secretary to the Compact Administration was also on line.

Mr. Cooley asked Mr. McDonald to state the reason for calling the meeting. Mr. McDonald explained that trans-mountain water from the Colorado River Basin was available for sale and that the State of Colorado and other parties desired to acquire such water to start the permanent pool in John Martin Reservoir.

After discussion, Mr. McDonald moved adoption of the following resolution:
