RESOLUTION CONCERNING THE JOHN MARTIN RESERVOIR OPERATING PLAN

WHEREAS, the Arkansas River Compact Administration has adopted a "Resolution Concerning an Operating Plan for John Martin Reservoir," which resolution was entered April 24, 1980; and

WHEREAS, paragraph VII of the said resolution provides that either Colorado or Kansas, through its compact delegation, can give written notice to the Administration by February 1 that the resolution shall be terminated on the next succeeding March 31; and

WHEREAS, discussions are presently under way among Colorado ditches and between Colorado and Kansas concerning possible modifications in the said resolution; and

WHEREAS, Colorado and Kansas agree that it would be desirable to extend such discussions beyond February 1, 1982;

NOW THEREFORE, BE IT RESOLVED that notwithstanding the provisions of paragraph VII. A. of the "Resolution Concerning an Operating Plan for John Martin Reservoir," either Colorado or Kansas, acting through its delegation to the Administration, may terminate said resolution on March 31, 1982, so long as written notification of such termination is provided to the Administration at its offices in Lamar, Colorado, on or before March 15, 1982.
