1	MORNING SESSION, December 9, 2008
2	VICE-CHAIRMAN: We are going to call the
3	meeting to order. I think we are ready to get started.
4	We welcome you all to the annual meeting of the Arkansas
5	or depending on how far east you are ar-Kansas
6	River Compact Administration meeting. Those of you who
7	weren't here for yesterday's committee meeting and
8	haven't been here before, I'm not Chairman Jennison. I'm
9	Vice-Chair Hayzlett. Chairman Jennison couldn't be here.
10	He had some family issues that prevented him from making
11	this in his schedule, and he sends his regrets and
12	apologies for not being able to make this meeting.
13	As vice-chair, they handed me the wheel, and I'm
14	going to try to steer us through this meeting as best I
15	can. But for those that are presenters and address the
16	committee, if you would come to the podium, state your
17	name and who you represent. That Will help the reporter
18	out as well as the rest of us. We're on a tight time
19	frame today. The reporter has a specified time to be out
20	of here.
21	So we are going to adjourn by 12:00. So you might
22	bear that in mind as you make your presentations. We

- 13 Tri-State litigation. I thought the appropriate place to
- do that would be between 5 and 6.
- 15 VICE-CHAIRMAN: Okay. The only other addition
- 16 from last night was 14.B.3. And I think that's some
- 17 recommendations on ten-year accounting. Any other
- 18 additions or revisions? If not, do I hear a motion to
- 19 accept the agenda?
- MR. HEIMERICH: So moved.
- MR. BARFIELD: Second.
- VICE-CHAIRMAN: Move to accept the agenda.
- 23 All in favor say aye.
- 24 (All said aye).
- VICE-CHAIRMAN: All opposed, say same. We'll
- 26 work off this agenda.

1 For reports of the Chairman; obviously Robin isn't here. The only thing he asked me to convey was that he 2 3 appreciates the work done on the Annual Reports. He said 4 there's been some progress made and that's been a goal of 5 his to get the Annual Reports going again. So he did 6 appreciate everybody's hard work on that and hopes it 7 keeps moving forward. Vice-Chair report. I don't -- Vice-Chairman doesn't 8 do a lot; only signs the checks that Stephanie sends to There's not a lot to report there. But there is a 10 resolution that we have -- I think Kansas has for Lee 11 12 Rolfs who has retired from the Division of Water 13 Resources. Do you have that, David? 14 MR. BARFIELD: Give me a moment. 15 MR. MILLER: If we can track exhibits and 16 resolutions as they are introduced. So like the agenda 17 and the attendance list. 18 VICE-CHAIRMAN: That's a good point. 19 MR. MILLER: So it's a part of the record. 20 MR. BARFIELD: I'm not finding my version. 21 Okay. Yes. I have a resolution I would like to offer 22 here. Let me go ahead and read it for the purpose of 23 those that haven't been a part of crafting this. Kansas 24 initiated it, and we offered it to Colorado. They

offered some helpful suggestions. Let me just read it:

"Whereas, Leland E. Rolfs, Esq., has provided 1 2 valuable guidance and advice to the Arkansas River Compact Administration (ARCA) as a trusted and respected 3 counselor at law for three decades; and 5 "Whereas, Lee has diligently represented the rights of the State of Kansas and its water users in a fair and 7 honest manner; and "Whereas, Lee has contributed much to Western water 9 law as a lawyer involved in innumerable water issues, as well as the landmark case of Kansas v. Colorado in the 10 United States Supreme Court; and 11 12 "Whereas, Lee's vast knowledge of water law, 13 positive attitude, friendly personality, and congenial 14 temperament have been an asset to ARCA; and 15 "Whereas, ARCA similarly finds that Lee was a 16 skillful, thorough, fair, and strong advocate for the State of Kansas, but always with civility, and honored 17 18 the legal profession throughout his long representation 19 of the State of Kansas at ARCA meetings. 20 "Now, therefore be it resolved that the Arkansas 21 River Compact Administration hereby expresses its 22 gratitude and appreciation to Leland E. Rolfs, Esq. for 23 his devoted service to ARCA and to the joint interests of the States of Colorado and Kansas, represented by ARCA; 24 25 and

1 "Be it further resolved that ARCA hereby extends its 2 best wishes to Lee in all of his future endeavors and its 3 fond wishes to him and his family for a long and happy retirement; and "Be it further resolved that the Administration 5 6 honor Lee by including this Resolution and his picture in 7 the Administration's Annual Report for Compact Year 2008, 8 and that the Recording Secretary send a copy of this 9 Resolution to Lee and his family." 10 Adopted by this Administration on today's date. 11 Anyway, I would offer this resolution for approval 12 by the Administration. 13 MS. GIMBEL: Second. 14 MR. HEIMERICH: Colorado second. 15 VICE-CHAIRMAN: Moved and seconded, we adopt 16 this resolution. All in favor say aye 17 (All said aye). 18 VICE-CHAIRMAN: Opposed? Same, sign. 19 Resolution adopted. The resolution probably doesn't need 20 an attachment, as it becomes a part of the minutes, I 21 assume. 22 MR. BARFIELD: I suppose that would be 23 Resolution 2008-1. 24 MR. DRAPER: Can I just add one thing?

VICE-CHAIRMAN: Yes.

1 MR. DRAPER: My name is John Draper. 2 worked with Lee over a long period, and I just wanted to 3 mention that in the discussions between the States in developing the motion, one of the suggestions from 5 Colorado was that Lee exemplified the very kind language 6 that the Special Master of the United States Supreme 7 Court directed towards the counsel in the case last year. 8 And, as you may recall, I think that was read into the 9 record last year, but Lee, probably, among those that are 10 involved, was probably one of the preeminent deserving of 11 that accolade from the Special Master. 12 VICE-CHAIRMAN: Very good. I think the 13 resolution says it well, the resolution of Lee. It 14 describes him to a "T" there. So we appreciate the work 15 he had done for us in the past. I think we are ready for 16 item 5, status of litigation. And, John, is that you? 17 MR. DRAPER: Sure. I didn't realize I was so 18 early on the agenda, but I would be glad to do that. 19 VICE-CHAIRMAN: We are moving right along. 20 MR. DRAPER: Very good. Dennis Montgomery is 21 also up here, he and I have been involved intimately in 22 the litigation. We just wanted to give you a quick 23 update on where that stands. The Special Master, Arthur 24 Littleworth, completed his Fifth and Final report last 25 January. It was in draft form when we had the ARCA 26 meeting last year, and it was mentioned at that time, but

1 since then the actual printed report has come out. Here 2 I brought a copy, at great personal effort, to the 3 meeting today. There's three heavy volumes here that 4 contain the report of the Special Master in the first 5 volume and then the proposed decree is contained in volumes two and three that has a lot of work that people 6 7 like Dennis Montgomery and others have contributed to. I 8 think many people in this room and elsewhere working for 9 the States have made it possible to achieve many things 10 in this decree by agreement once the guidance was received and 11 critical issues from the Special Master and the Court. 12 And the last volume is one of the Appendices. 13 is the H-I Model documentation, and I wanted to bring 14 these today so that anybody who is interested in actually 15 seeing these could do so. I might mention that the model 16 itself is on a DVD in the back of the third volume for 17 anybody who is interested in electronic detail. The 18 States this year have dealt with the report in this way. 19 Kansas filed an exception to the taxation of costs in the 20 And these are what these briefs look like. case. 21 Colorado responded. Here's a copy of Colorado's brief 22 that I brought for people to look at if they were 23 interested in it. 24 The Supreme Court held oral argument on that case 25 last Monday, just a week ago yesterday, in which the 26 Attorneys General of the two States argued the case --

- 1 Attorney General Suthers for Colorado; and Attorney
- 2 General Six for the State of Kansas -- and I was there
- 3 and so was Dennis. And I would say it was quite lively
- 4 questioning from all of the Justices. And so that's a
- 5 step in bringing this case to final resolution.
- 6 At this point there are two issues that we're still
- dealing with that grow out of the case: One is the
- 8 evaluation of the sufficiency of the Use Rules and their
- 9 administration. There's a provision in the decree for
- jurisdiction to be retained with respect to that. And
- 11 the States have been conferring through their experts on
- those issues. And I would say we have been making very
- good progress. And we have a deadline of December 31st to
- 14 notify the Special Master if we haven't completed our
- 15 negotiations or to otherwise resolve it by that time in
- 16 the retained jurisdiction.
- 17 And then the other pending issue that grows out of
- 18 the case is that we, that is Kansas, has notified
- 19 Colorado that we do have problems with the LAWMA decree.
- 20 And that we are planning to challenge that as authorized
- 21 by the U.S. Supreme Court. There, again, though, we have
- 22 had some discussions. And while we haven't made a whole
- lot of progress at this point, we hope that we can make
- 24 at least some progress in minimizing the issues that
- separate the States on that decree.

1 I think that covers all of the current stuff, Mr. 2 Chairman. 3 VICE-CHAIRMAN: Okay. Thank you. Dennis, do 4 you have anything to add? 5 MR. MONTGOMERY: The only thing I would add is 6 that the Special Master in his Fifth and Final Report 7 recommended that the U.S. Supreme Court enter the proposed decree and neither State took objection to that 8 9 recommendation. So the only issue for the Court to 10 resolve at this point is the question of costs. And I 11 would expect that, based on the time table it took the 12 Court to resolve other issues, we will see a decision in 13 probably a month to six weeks. 14 VICE-CHAIRMAN: Okay. Very good. Any 15 questions? If not, we'll move on to item B, Colorado 16 compliance. That's the next on my agenda. And who is 17 going to do that, the Colorado compliance efforts? Is 18 that you, Steve? You sat in the front row for a reason. 19 MR. WITTE: Not this reason. Good morning. 20 My name is Steve Witte. I guess I would report that over 21 the course of the last year, Colorado has continued to 22 implement the amended ground water measurement rules and 23 ground water use rules that were put into effect in the 24 early to mid-90's to good effect, we believe. 25 The proof is in the pudding, if you will, in that

during the period 1998 through 2007, the States of

Colorado and Kansas have agreed to a ten-year accounting 1 2 of depletions of accretions to Useable Stateline Flow. And over that ten-year period Colorado has -- or there 3 are accretions of 18,218 acre feet largely due to the 5 implementation of our ground water use rules to ensure 6 replacement of depletions to useable Stateline flow. 7 There was some discussion regarding this table. It's a table that's been agreed upon or will be required through 8 9 Exhibit E, I believe, in the final decree. And there was 10 discussion last evening that perhaps this table ought to 11 be incorporated in future reports of ARCA. And I would suggest to you that that would perhaps be an appropriate 12 13 thing for you to adopt. 14 There has been discussions regarding the sufficiency of the presumptive depletion factors that are utilized in 15 16 the ground water use rules. And those discussions are 17 continuing. Finally then, I would point out that the State of Colorado has been involved in a process that is 18 19 intended to lead to the promulgation of rules. We call 20 this additional set of rules that we refer to as the 21 short title as being the Irrigation Consumption Rules 22 that would regulate use of improved irrigation 23 distribution methods that would have the potential of causing additional depletions to useable Stateline flow. 24 Where we're at in that process right now is that an 25 26 advisory committee has been created by State Engineer

Dick Wolfe and comments have been received and continue 1 to be received that have led to a number of modifications 2 3 to the draft of the rules that was presented at last 4 year's meeting. And there was a briefing to the Engineering Committee yesterday on those rules. So -- I 5 6 believe that would conclude my report at this point. VICE-CHAIRMAN: Okay. Anybody have questions 8 for Steve? 9 MR. BARFIELD: I don't have any questions, but 10 I guess maybe this might be the appropriate time to 11 comment, particularly on the last item that you 12 mentioned. And that's the rules you're considering 13 working toward adopting related to improved efficiency. 14 This is a real concern. I remember attending a meeting a 15 couple of years ago at Rocky Ford where Hal Simpson and 16 David Pope sort of exchanged views on this issue. You know, this is a concern for Kansas, and I think others in 17 18 Colorado. We would like to not get in the way of these 19 efficiency improvements. We think that in these cases 20 they are a very valuable thing for improving water use 21 and water quality concerns but needs to be done in an 22 appropriate way. 23 Then I guess we would commend Colorado for their 24 proactive work here. Obviously, we just got the 25 materials. We appreciated Dick's presentation yesterday

and our opportunity to discuss it last night, and we'll

1 give these some serious review and seek to provide you 2 some substantive feedback as soon as we can. Thank you. 3 VICE-CHAIRMAN: Thanks, Steve. Our next item I think under 5.C. is Tri-State. And, Eve McDonald, I 5 believe, you're on now. 6 MS. MCDONALD: Thank you, Mr. Vice-Chairman, 7 for the opportunity to update ARCA on this case. Last 8 year right after Tri-State had filed this large change 9 application, they made a presentation to ARCA. And this 10 year I just want to give a brief update and let you know 11 that we have had quite a pleasant experience working 12 together, the two States, this year on resolving the 13 Compact issues that were raised by that case. And I got 14 to work with Bill Tyner, who is the lead engineer on the 15 Colorado State Engineer's team, and we worked with Kansas 16 to find out what issues Kansas saw raised by the decree 17 that was proposed by Tri-State to identify all of them. 18 And, as John Draper said a moment ago, tried to minimize 19 the areas where the two States differ. And I think we 20 did a great job of that. We had help from Mr. Draper and 21 from Mr. Book and from Brandy Cole and kept the 22 communication lines open, and I think it might be a nice 23 way we can proceed when other significant change 24 applications are filed in the Arkansas basin. Thank you.

1 VICE-CHAIRMAN: Any questions for Eve? We 2 appreciate the report and glad to hear that you can work 3 together. 4 MR. BARFIELD: Let me again note no 5 questions, but I also would concur. I appreciate the 6 efforts by all here to seriously consider the comments 7 and concerns of the State of Kansas on this; and, again, 8 we look forward to continuing to work with you to sort of complete that process. So -- John, would you have 10 anything to add to that? 11 MR. DRAPER: Nothing significant. Just that I 12 would second in the note of appreciation. I think it 13 bodes well for cooperation between the States, especially 14 in matters that have the high potential to effect Compact 15 issues for Colorado to proceed the way it has on this issue. We appreciate it. We have tried to provide 16 17 useful substantive comments. You can't expect complete 18 agreement but we have agreement on very many of the issues. And I think that bodes well for interstate 19 20 cooperation on this river. Thank you. 21 VICE-CHAIRMAN: Any other comments? Okay. 22 Hearing none, I guess we're ready to move on to the 23 reports from the federal agencies. I have USGS as the 24 first, Pat Edelmann? 25 MR. EDELMANN: Good morning. I'm Pat 26 In 2008, ten stream locations were upgraded Edelmann.

1 under the USGS/ARCA cooperative program -- eight in 2 Colorado and two in Kansas -- on June 9th and 10th as a 3 follow-up action item from the December 2007 ARCA meeting, Bill Tyner with Colorado Division of Water 5 Resources, Kevin Salter and Brandy Cole, Kansas Division of Water Resources, Craig Dare, Bill Bemis, Bill Payne 6 and myself with USGS, visited all ten gages. Subsequent 7 to the site visit, Bill Tyner drafted a document 8 9 providing a review of the stream gages and made the 10 recommendations for continued operation or improvement of those gages. The document was subsequently reviewed by 11 12 all the attendees that were up from the site visits. Revisions were made and the report was subsequently 13 14 submitted to the Engineering Committee. 15 No significant problems were encountered in the 16 network with the exception of recurring beaver dam problems at Big Sandy near Lamar gage. The Colorado 17 18 Department of Transportation is now involved in removal 19 of beaver dams at Highway 196 just below the gage, has recently involved a trapper to remove beavers from that 20 area. Colorado and Kansas staff recommended that all 21 22 gages, including Big Sandy gage, continue to be operated. In 2009, the USGS proposes to continue operation of 23 24 the ten gage locations and monitor the situation of Big Sandy gage. If we cannot resolve the beaver problem, we 25

will make a subsequent recommendation that we either drop 1 2 or move that gage to a seasonal operation. A summary of the flows for water year 2007. So 3 October 2007 through September 2008 is as follows. That 4 5 Arkansas River in Las Animas, there was 204,500 acre feet; at Purgatoire River near Las Animas, there's 29,460 7 acre feet; at Arkansas River below John Martin Reservoir there's 222,600 acre feet, which was 5 percent less than 8 9 2007 but about 9 percent greater than the long-term 10 average; at Arkansas River at Lamar there is 51,100 acre feet; Big Sandy Creek near Lamar, it is estimated there's 11 9,650 acre feet; Arkansas River near Granada was 69,710 12 acre feet; Wildhorse Creek near Holly there's 3,540 acre 13 14 feet, which was comprised during October-November and 15 April-September. That gage is not operated for a full 16 year. Arkansas River near Coolidge, there's 97,260 acre feet, which was 24 percent less than 2007, about 17 17 18 percent or 18 percent less than average; Frontier Ditch 19 near Coolidge had 8,660 acre feet, which is 18 percent 20 more than what was diverted in 2007. 21 And that concludes my report. If there are any 22 questions, I would be happy to try to address those. 23 VICE-CHAIRMAN: Questions or comments? 24 MS. COLE: What did you say the Stateline was?

1 MR. EDELMANN: Arkansas River near Coolidge 2 was 97,260 and Frontier Ditch was 8,660. And I have that 3 information here to pass out. 4 VICE-CHAIRMAN: Do you have the report to 5 attach? 6 MR. EDELMANN: I do. 7 VICE-CHAIRMAN: That was a good report. I 8 read through it, and I thought that was real helpful to 9 identify the gages. I thought that was a good report. 10 Yeah, Steve? 11 MR. MILLER: I have a question. Without 12 putting you on the spot, would you mind saying a few 13 words about some of the cooperative studies that you are 14 doing with us with regards to water quality in the State. 15 MR. Edelmann: There's several activities that 16 USGS is doing elsewhere in the basin. Some of those 17 activities with the Colorado Water Conservation Board 18 include a continuing of effort to begin a comprehensive 19 water quality evaluation throughout the basin. And so 20 the Colorado Water Conservation Board provided us some 21 funds to do a couple of things. One was to help compile 22 all of the water quality data in electronic format and 23 the other entities that were willing to provide to us. 24 We have that data compiled. We have got it in a variety 25 of different sets that are merging into a central 26 database, and we hope that in -- by January 15, we'll

1 have a pilot version of a website that people can go to 2 and download water quality data that's throughout the 3 basin from like a whole host of entities. I can't say it's everybody, but it's everybody that would provide their data in electronic format. Subsequent to that, we 5 6 are also working on a variety of scopes of work to deal with various water quality issues, various parts of the 7 8 basin. We'll have that out and be running that by a 9 group that we refer to as the Regional Resource Planning 10 Group, which are some of the major entities in the basin 11 that fund water quality work. They -- I hope I don't 12 miss anybody - they include the Upper Arkansas Water 13 Conservancy District, City of Aurora, Colorado Springs 14 Utilities, Pueblo Board of Water Works, Southeast 15 Colorado Water Conservancy District, Lower Arkansas 16 Valley Water Conservancy District. We'll expect -- we'll 17 also give partnerships from Pueblo West, City of Pueblo, 18 City of Fountain, and a variety of other entities with 19 that. 20 Couple of other things that will be happening 21 specifically at Fountain Creek, so further up in the 22 watershed. This year we will be finishing a report on 23 the microbial source tracking for the Upper Fountain 24 Creek and looking at where the sources of E. coli are 25 that have impaired that stream segment. And we're also looking at finishing up a pilot test of a 26

1 multidimensional sediment transport model that can look 2 at sediment transport, and they have material, the 3 erosion capabilities and so forth along Fountain Creek. So, Steve, is there anything else that I have left 5 off that you --MR. MILLER: Nothing comes to my mind. 6 7 sure you are doing a lot more than you just said. I 8 appreciate it. 9 VICE-CHAIRMAN: Any other questions for Pat? 10 MR. BARFIELD: I just appreciate this report. 11 I quess, obviously water quality is of significant 12 concerns on both sides of the Stateline. I know there's 13 other dialogues occurring between the water quality 14 agencies, and we just need to keep working together on 15 these issues. MR. EDELMANN: David, I've missed when you 16 17 mentioned that we are also in the process of preparing a 18 basinwide report based on this available data that will 19 look at loading of the salinity, if there's adequate 20 enough data and characterization of uranium occurrence 21 and distribution throughout the basin as well. 22 VICE-CHAIRMAN: Thank you. I believe we are 23 ready for the Army, Major. MAJOR BALYOZ: Good morning, Mr. Vice-Chairman 24 25 and members of the Arkansas River Compact. I am Major

Andre Balyoz, Deputy Commander for the Albuquerque

1 District, U.S. Army Corps of Engineers. Lieutenant 2 Colonel Kim Colloton is the newly appointed Albuquerque District Commander. Both Colonel Colloton and I began 3 working in the Albuquerque District this past July. She 5 was planning on giving this presentation and was truly disappointed when her schedule changed and she wasn't 6 able to do so. But she does send her regards. She has 7 8 reviewed the information that I'm presenting to you 9 today. 10 I thank you for the opportunity to present key topics from our report of the last year and items of 11 12 current interest. As you have already heard, joining me 13 from the Albuquerque district office are April Sanders, 14 our Reservoir Control Branch Chief; Karl Arton, down 15 there on the end, the Lake Operations Branch Chief; Dennis Garcia from the Reservoir Control Branch; and we 16 also got Van Truan, the Pueblo Regulatory Office Chief; 17 18 and Sandy Rayl, our Colorado Programs Manager. And 19 joining us from the South Pacific Division Headquarters 20 Office, we got Mr. Paul Robershotte, the newly appointed 21 special advisor for integrated water source planning; and 22 Mr. Patrick Oyabe, the executive assistant to the 23 commanding general, Brigadier General John McMann. 24 The upper Arkansas River basin, in terms of 25 snowpack, reached a well above normal high of 147 percent of average this year. The southern sub-basins were also 26

- well above normal at 173 percent of average. There were
  no Corps flood control operations up at Trinidad, John
  Martin, or Pueblo reservoirs this year.
- 4 Work on studies and projects with basin sponsors 5 under the Corps mission of flood damage reduction, 6 ecosystem restoration, and Clean Water Acts compliance 7 continued in 2008. And I will highlight a few of these 8 projects. First, within our General Investigations program the Fountain Creek Water Study is ongoing and 10 will be complete in 2009. A draft report of the study 11 was released in November of this year. The study 12 analyzes the entire watershed to identify a suite of 13 projects to address flood damage reduction, ecosystem 14 restoration, and channel stability. This study will not 15 directly lead to construction of specific projects but 16 will culminate with a watershed feasibility document 17 defining implementation strategies and project delivery 18 mechanisms for the suite of available projects. Baseline 19 environmental, hydrology, and hydraulics conditions are 20 complete and the Corps and project sponsors are currently 21 prioritizing 46 potential projects and delineating 13 for 22 more detailed studies.

The Arkansas River Fisheries Habitat Restoration. A section 206 aquatic restoration project is nearing completion in the ten mile mainstream reach downstream of Pueblo Dam. This project sponsored by the City of Pueblo

- and initiated in 2002 will improve fish and riparian 1
- 2 habitat. Stream habitat channels structures, and some
- riparian and bank plantings were completed in 2006 and 3
- exotic vegetation removal, mainly of tamarisk and Russian
- Olive, and replanting are scheduled to the end of 2008. 5
- The Albuquerque District issued six individual
- Section 404 CWA permits in the basin in 2008 with an 7
- 8 additional 274 activities reviewed and covered by
- 9 nationwide permits.

10 I would also like to address a couple of current items of interest. At John Martin, an accumulation of 11 12 sediment on the dam's upstream face, is hindering 13 scheduled maintenance and the inspection of emergency 14 gates. In order to alleviate this problem, the Corps has 15 issued a \$3.1 million project to hydraulically remove 16 approximately 90,000 cubic yards of sediment material of which over 20,000 cubic yards have already been removed. The dredging material is being deposited in the retention pond that's about a mile and-a-half from the dredging site where it will be used in the future construction of endangered species habitat islands. The operation is ongoing and is on schedule to be completed by February of 2009. Hydraulic dredging is the best method for removing these sediments. We are confident that the operation will have the least impact on turbidity and not result in action level increased concentrations of organics or

- 1 metals. The Corps is following best management practices
- during construction in accordance with our construction
- 3 stormwater permit.
- 4 At Trinidad, the Corps, along with the United States
- 5 Bureau of Reclamation and other State and local agencies
- 6 pursued efforts to combine resources in FY08 to conduct a
- 7 study to definitively determine the existing hydraulic
- 8 capacity of the Purgatoire River below Trinidad Lake. To
- 9 date, mapping data has been collected and the hydrologic
- 10 modeling effort is underway. Model results will also be
- 11 available in February 2009.
- 12 And, finally, as you are all aware, we have some
- important activities going on around the country and the
- 14 world. I want to conclude with a few words about two
- priority missions for the Corps of Engineers. Support
- for the global war on terror and Gulf Coast recovery.
- 17 While, I get frequently reminded that Corps employees are
- 18 not soldiers, I am proud to say that 16 civilian
- 19 district members voluntarily deployed to Iraq,
- 20 Afghanistan or the Gulf Coast region this year. And we
- 21 currently have nine employees in harms' way, including
- our newly selected OPM for John Martin, Ms. Karen
- Downing.
- 24 Also this year over 6 percent of our district served
- on the Corps National Ice Planning and Response Team
- 26 which was responsible for the purchasing, transporting,

- 1 and delivering emergency supplies of ice as part of FEMA
- 2 National Disaster Response Operations in response to
- 3 hurricanes Gustoff, Ike and Hannah this fall.
- 4 Also this year the district brought on four
- 5 noncommissioned officers who recently returned from
- 6 deployments overseas and that are in the Wounded Warriors
- 7 Program.
- 8 This concludes my report to the Compact. At this
- 9 time I would be happy to answer any questions you might
- 10 have.
- 11 VICE-CHAIRMAN: Thanks for the report. We do
- 12 appreciate all of your service in whatever capacity that
- might be. Are there any questions or comments?
- 14 Jennifer?
- MS. GIMBEL: To the Bureau of Reclamation,
- this is heads up. Tell me about what the Corps is doing
- to help the State with the aquatic species that we're
- dealing with, mussels.
- 19 MS. RAYL: Sandy Rayl, U.S. Army Corps of
- 20 Engineers. We are working with the Division of Wildlife
- 21 and the State Parks office trying to identify where there
- 22 might be potential for veliger which is the larva form of
- 23 the mussel. Also trying to track to see where there have
- been reported cases. Clearly, It's a concern in the
- reservoirs, and so I think they are looking at measures
- 26 that might include cleaning boats and dumping bailage

- 1 water and whatnot to try to make sure that materials are
- 2 not introduced into the lakes and monitoring.
- 3 But, essentially, at this point that's what the plan
- 4 is monitoring. But we're very much aware of this. I
- 5 have been disseminating any information that I receive
- from the 100th Meridian Program to try to -- I know that
- 7 it is a concern to try to minimize or make certain that
- 8 these mussel do not occupy the lakes in Colorado to a
- 9 large extent. So anyway --
- MS. GIMBEL: And the 100th Meridian Program,
- is that a federal program? Is it a combination of an --
- MS. RAYL: It's a combination program. It's a
- 13 nationwide program. Essentially, I think it was
- initially started as a federal program, but it's keeping
- track and making recommendations for how some of these --
- 16 various treatment methods. So they are looking at
- potential for fish, other types of treatment measure.
- 18 But right now I think the focus is just on trying to
- 19 clean boats, dump bailage water in defined locations
- where that water can be safely removed.
- 21 MS. GIMBEL: Just to add also, isn't there a
- 22 conference in January of this Hundredth Meridian out of
- Denver? Are you aware of that?
- MS. RAYL: I do not --
- MS. GIMBEL: I thought I saw an email like
- 26 that.

1 MS. RAYL: We can follow up on that. 2 MS. GIMBEL: Thank you. 3 VICE-CHAIRMAN: Matt? 4 MR. HEIMERICH: Major, I was just curious. I 5 think the two gentlemen from San Francisco might win the 6 award for traveling furthest to get to an ARCA meeting 7 here in Lamar, and I was wondering if in fact they are 8 here for a specific reason or -- and I know we are under 9 a time restriction, but I wondered if since coming so far 10 from the West Coast if they have anything to share with 11 ARCA, and it would be with the Chair's indulgence, I 12 would invite them to say something if, in fact, they care to. Gentlemen? 13 14 MR. ROBERSHOTTE: Good morning. My name is 15 Paul Robershotte. I'll try not to take long here. 16 reason we are here is to observe the activity, one, its 17 watershed based which we support and endorse; and also to 18 introduce me to a number of folks. I'm newly joining the 19 Corps in the Division to better appreciate all that's 20 going on within the Division. And to better understand 21 where we can support and assist early in the process. So 22 it's really an observation. 23 MR. HEIMERICH: Thank you. Thank you, Mr. 24 Chair. 25 VICE-CHAIRMAN: Thank you. Any other questions or comments? Hearing none, that attachment 26

- there, the handout will be an attachment in front of you
- there. Okay. Ready for the Bureau? And I didn't know
- 3 which one of you guys wanted to start it first, but you
- 4 get the honor.
- 5 MR. GOODENOW: Good morning. I'm Greg
- 6 Goodenow. I'm the Chief of the Resources Division with
- 7 Eastern Colorado Area Office, Bureau of Reclamation. I'm
- 8 new to the position so this is new for me as well as my
- 9 being new to Reclamation. So I appreciate being here,
- 10 and I appreciate all the information. Reclamation staff
- is also here today with me to update you on our
- 12 involvement in the update of the Operating Principles of
- 13 the Trinidad Project, Fryingpan -- I'm sorry -- our
- 14 operations on Fryingpan Arkansas Project including Pueblo
- 15 Dam. With me is Roy Vaughan, our facility manager with
- 16 Pueblo. And I will conclude with a brief update on the
- 17 Southern Delivery System.
- 18 VICE-CHAIRMAN: Thank you, Greq.
- 19 MR. GILMORE: My name is Andrew Gilmore. And
- 20 I'm with Reclamation in Loveland's Eastern Colorado Area
- 21 Office. My point of discussion is review of the -- we
- 22 tender review of the Operating Principles of Trinidad
- project and our involvement in this stems from the
- 24 repayment contract that we entered into with Purgatoire
- 25 for a portion of their construction costs for repayment
- obligations. And to one I want to introduce is the

1 point of the contract with that is we review every ten 2 years the updating of the principles of the Trinidad 3 Project. These reviews -- the principal purposes of these is to obtain optimal beneficial use of water, as 5 conditions change, experience is gained, more technical 6 data becomes available. And this review process is important to Reclamation. That's why we are here. The most recent ten-year review was initiated in 9 March of 2005 and is progressing. The draft of this 10 report will be available for review by March 15, 2009. I 11 would like to bring up just two items from the contents 12 of that review. The other people have addressed us at 13 this meeting have already summarized those contents. But 14 two items that I would like to underline. Reclamation 15 made an updated model which mimics the models that 16 previously run off on the Trinidad Project to 2007. 17 continue to engage all the interested parties to employ 18 this model in their analysis. The second item is that 19 this ten-year review document is intended to be a 20 reference document containing relevant documentation, 21 letters and amendments that are germane to this 22 discussion and review of ten-year Operating Principles. 23 VICE-CHAIRMAN: Roy, do you have something? 24 MR. VAUGHAN: My name is Roy Vaughan. I'm the 25 manager of Pueblo Reservoir. My office is responsible for the operations of the east slope reservoirs on the 26

- 1 Fryingpan-Arkansas project and the collections system.
- 2 As the Corps said earlier, it was a great year in the
- 3 basin for water. Boustead tunnel, we imported 89,960
- 4 acre feet from west slope collection system, which is 185
- 5 percent of our 25 year average. That's, of course, the
- 6 fourth best year we have had since 1972.
- 7 I'll give you a little update on the current storage
- 8 numbers: in Turquoise is 115 percent of normal; Twin,
- 9 107; Pueblo Reservoir is 138 percent of normal. So our
- 10 east slope reservoir status is 120 percent of normal.
- I'll touch on a little bit, you know.
- MS. GIMBEL: Pueblo?
- MR. VAUGHAN: Well, not that I'm the expert.
- MS. GIMBEL: Mussels?
- MR. VAUGHAN: But I'm going to take that on
- 16 today. Reclamation is -- we have kind of come up with a
- 17 corporate approach. We deal with the same partners.
- 18 We're heavily involved because of the Pueblo Reservoir
- issue, but we have completed a facility review of Pueblo
- and we plan on doing that to all of the Reclamation
- 21 reservoirs. And what it does is it evaluates the risk,
- 22 some kind of remediation options, and we get a lot of
- 23 experts to look at that, and we have a peer review of the
- private consultation. So that's kind of where we are
- 25 headed as a corporate approach to Reclamation as a whole.
- 26 If anybody has any questions for me?

1	VICE-CHAIRMAN: Questions?
2	MR. VAUGHAN: It's not a pleasant thing, but I think it's
3	something we're all going to have to deal with. Thank
4	you.
5	VICE-CHAIRMAN: Thank you, Roy.
6	MR. GOODENOW: A quick update on the proposed
7	Southern Delivery System. The Southern Delivery System
8	is a nonfederal project proposed by the cities of
9	Colorado Springs, Security, Fountain, and Pueblo West.
10	The proposed project will include water contracts with
11	Reclamation by applying for diversions from or near the
12	Pueblo Reservoir outlet manifold, and Colorado Springs'
13	two new reservoirs. The proposed project is within the
14	boundaries of the Fryingpan-Arkansas project and would use
15	our project facilities. And that is Reclamation's involvement.
16	In February 2008 Reclamation issued a draft
17	environmental statement. Based on the findings of that
18	draft and public input, Reclamation conducted additional
19	analysis of the environmental implications of the
20	project. That information was published in a
21	supplemental report referred to as Addendum A on October
22	3, 2008. The most substantial changes to be reported
23	were the modifications by the project participants to
24	avoid or minimize various effects that have been
25	identified in draft. The report also summarized the
26	results of additional water quality analysis, additional

- studies of impact to steam influence on the western slope
- 2 and a dam failure analysis.
- 3 Upcoming milestones to report that are anticipated.
- 4 We hope that a final Environmental Impact Statement will
- 5 be released by mid-December, middle of this month, with a
- 6 Record of Decision following by mid-January. And we,
- 7 Reclamation, will be initiating negotiations on water-
- 8 related 10 contracts with the project participants for
- 9 use with facilities once a basis of negotiations has been
- 10 approved.
- 11 Questions? If you have questions or comments, my
- name is in the sign-up sheet. Please contact me.
- 13 VICE-CHAIRMAN: Any questions? Jennifer?
- MS. GIMBEL: Greq, thank you very much,
- 15 Andrew. First of all, I would like to thank you for
- 16 giving us the time when the Trinidad report is going to
- 17 be out, the draft report, as you're both new. And so I'm
- sure you are aware that this group has been a bit
- frustrated about how long it's taken us to get what we're
- 20 getting. So I really appreciate you coming here and
- 21 saying we're going to get this to you. So thank you for
- that.
- MR. GOODENOW: You're welcome. I wanted to
- 24 make sure Andrew came. I felt it was important that you
- 25 see his face as the person who has the primary

responsibility as the author and is the manager 1 2 overseeing that. MS. GIMBEL: Thank you. 3 4 VICE-CHAIRMAN: Any more questions? MR. BARFIELD: Just a similar comment, I 5 quess. We also, I quess, share some of the same 6 sentiment. For us the ten-year review is an opportunity 8 for a substantive review of the operations of the 9 District. That's compliance with the Operating 10 Principles. And, so, and I quess we look forward to the 11 next steps in this process as well. 12 MR. GOODENOW: If you have specific questions or concerns, feel free to give us a call or email or 13 14 write us. 15 VICE-CHAIRMAN: Thanks to all three of you. Is that a document that you want made as an attachment or is 16 17 that just your --18 MR. GOODENOW: Just my notes. Thank you. VICE-CHAIRMAN: Item 7 on the agenda now, tag-19 20 team between Susan and Jean? 21 MS. METZGER: I do have a handout. I think I have enough for sharing with the audience. My name is 22 23 Susan Metzger. I'm with the Kansas Water Office, and I also serve on the Board of Directors for the Tamarisk 24 Coalition. Thank you, Mr. Vice Chairman and the 25

Administration for having me here today. I'm just here

1 to provide a brief update on some tamarisk activities. 2 Yesterday the engineering subcommittee had an 3 opportunity to hear a more comprehensive report from Jean 4 Van Pelt, Southeast Colorado Water Conservancy District. 5 I don't want to duplicate any conversations she might 6 have had with you. So my focus today is to talk a little bit about a 8 project that Kansas implemented this past year, working 9 on the tamarisk issue and our watershed. That map that I provided to you is double-sided. On one side, you see 10 11 the first few counties in Kansas from Hamilton County all 12 the way down the river to about Gray or Hodgeman County. 13 And what you are going to see there is a level of 14 infestation of tamarisk along the Arkansas River and it's 15 highest on our shared border and diminishes as we go 16 further into the State. Collectively between Kansas and 17 Colorado, we have about 78,000 acres of tamarisk 18 infestation, which we could go on and on about the pros 19 and cons of tamarisk. But a couple of common concerns is 20 it narrows the river channel so it increases flooding, 21 reduces our full capacity and our access to that water, 22 increases fire potential and reduces habitat. 23 So we certainly recognize that we can't tackle that 24 issue on a landowner basis, on a county basis or even on 25 a statewide basis, because the plant doesn't seem to know

those boundaries very well. So Jean and myself this past

1	year have been working to pull together various
2	stakeholders in our collective watershed to address this
3	issue commonly. So we have a couple of things that I
4	think Jean had presented to you to maybe make that more
5	concrete; but, regardless, Jean and I are committed to
6	move forward today to keep Kansas and Colorado charging
7	forward on tackling tamarisk. So the other side of that
8	map there, you can see a project that Kansas worked on
9	this past year in Hamilton County, the kind of aerial
10	image there. The area showing yellow were treated with
11	chemical known as Habitat aerially with a helicopter; and
12	Hamilton County with State funding, we were able to treat
13	350 acres of tamarisk and then elsewhere in the watershed
14	in Kansas we treated about 200 acres with State funding.
15	As we worked with local stakeholders in applying for
16	State funds, some local land owners and additional
17	entities came forward and treated an additional 90 acres,
18	which we were pretty proud of. We think pretty good
19	about 500, 600 acres and applying \$70,000 worth of funds,
20	but I mentioned 78,000 acres of infestation in the State.
21	So certainly not with only local budgets or State
22	budgets are we going to be able to tackle this issue. So
23	the real benefit of cooperative efforts between Kansas
24	and Colorado is the opportunity to go forward for seeking
25	federal funds, which is something we really want to work
26	towards together so we have more funding to dedicate

- 1 towards this project. So, with that, if Jean wanted to 2 offer up anything, too, that would be great. 3 MS. VAN PELT: I'm Jean Van Pelt with 4 Southeastern Colorado Water Conservancy District. And 5 our district has actually headed up the efforts in 6 Colorado's Arkansas River basin to develop a strategic plan for the control. We have partnered with the Kansas 8 Water Office and several of the local county 9 commissioners in Kansas that are right within the 10 Arkansas basin to develop this plan and to work 11 cooperatively toward pursuing federal funding for this. 12 Susan did a beautiful job speaking on our behalf. And in 13 lieu of saving time, I think I'll just offer this 14 resolution that has been modified here. A couple of 15 changes, mostly just little typos and things like that. 16 Nothing to the content. 17 VICE-CHAIRMAN: Summary of the resolution 18 draft that you had last night? 19 MS. VAN PELT: Yes. 20 VICE-CHAIRMEN: Any questions?
- MS. METZGER: Um-hum.

21

MR. HEIMERICH: So as the infestation starts

- 25 to peter out, is that simply because -- is it
- 26 environmentally -- I mean, culturally that the plant

MR. HEIMERICH: Ms. Metzger, on this sheet, on

- 1 can't survive in those regions, or is it just hasn't got
- 2 there yet?
- 3 MS. METZGER: Some of it is a mix. I hope not
- 4 all of it because it hasn't gotten there. The level of
- flow is higher at the Stateline so the movement of the
- 6 seed source is benefited from that and so it dries out
- 7 past Garden City. And so this seed source isn't as
- 8 effective in moving forward.
- 9 MR. HEIMERICH: Right.
- 10 MS. METZGER: Also, it is a salt-loving plant,
- 11 and there are higher salinity levels in western Kansas
- 12 and it diminishes as we move further east. So a couple
- of things that really benefit the species the first two
- 14 counties on the Stateline.
- MR. HEIMERICH: But, pardon me, so if it is
- 16 nothing but a flow was to increase, I mean, plants
- 17 certainly evolve and change as well. I mean, there's
- 18 nothing to prevent it to keep migrating further down the
- 19 stream except it might not be quite as extensive as it is
- in the upper reaches or at least the reach along our
- 21 borders. Would that be correct, do you think?
- MS. METZGER: That is true. Part of the
- 23 reason we had focused on Hamilton County this year is
- 24 because it has such a high level of infestation. And so
- working on reducing the level of seed source is certainly
- 26 going to help those downstream counties.

MR. HEIMERICH: Very good. Thank you, Susan. 1 2 VICE-CHAIRMAN: This area that you did on this 3 map is about two miles, is it? MS. METZGER: That's right. Between Stateline 4 5 and Coolidge. VICE-CHAIRMAN: About a two-mile stretch 6 7 there. Other questions for either one of these ladies? 8 We appreciate your reports and the purpose of the 9 resolution, I think, is just to help shore up some 10 federal funding? Is that your thoughts there? 11 MS. METZGER: Exactly. Yes. We're looking for your endorsement where we can actually go out and say 12 ARCA is behind us with pursuing federal funding. 13 14 VICE-CHAIRMAN: Thank you. MR. BARFIELD: Right. So this agenda item or 15 16 resolution will be considered under agenda item 14.A 17 later in the meeting. 18 VICE-CHAIRMAN: That's correct. We're moving 19 right along. We are ready for the reports from the conservancy districts. I have the Southeastern as the 20 first on my list. Is there someone here from Southeast? 21 22 MR. MILLER: I was supposed to tell Jennifer 23 Jim Broderick couldn't be here. He's in 24 Washington. 25 MR. BARFIELD: Steve, why don't you come

26

forward?

MR. MILLER: I just want to give Jim's 1 2 He normally had a conflict with a watershed regrets. 3 meeting in Las Vegas, but this year that didn't happen so 4 he was looking forward to being here. And he found 5 himself having to go to Washington this week, some 6 funding issues with the Arkansas Valley Conduit, so he 7 sends his regrets. He renews his invitation to Kansas, and if there are other folks that want to know about the 8 9 projects that the Southeast is conducting, to him to go 10 to Topeka and there's things that he needs to talk about, 11 or you're certainly welcome to come over here and look at 12 some of the things. Maybe next year he'll actually be 13 here in person. 14 Thanks, Steve. The Lower VICE-CHAIRMAN: 15 Arkansas Water Conservancy District? Do we have someone 16 to report for them? 17 MR. HEIMERICH: Mr. Chair, I don't see - I 18 didn't hear nor do I see anybody from the Lower District. 19 I do see Dr. Danielson here from the Purgatoire. 20 VICE-CHAIRMAN: Dr. Danielson from Purgatoire, 21 do you have something? 22 DR. DANIELSON: Thank you, Mr. Chairman and 23 members of the Administration. I'm Jeris Danielson. 24 the general manager for the Purgatoire River Water 25 Conservancy District in Trinidad. I found it kind of interesting. I worked with Lee for a long time and he's 26

- 1 now -- I won't say passed on -- but retired. Things 2 change. In the good old days that many doughnuts would 3 not have survived until 10:30. So I don't know what's 4 going on. Just a couple of comments. We had a sad event 5 at the Purgatoire Board this year. Erma Evans, whom many 6 of you may remember, passed away very suddenly. And so 7 you can expect your meetings to be less lively now. We 8 have four new board members. The weather report from 9 Trinidad -- I was hoping to introduce some of them -- but 10 they have 14 inches of snow on the level at Trinidad this 11 morning. So they didn't make it. 12 A lot of things happening in the Purgatoire 13 District. Change -- Coal bed methane is a major issue in 14 Las Animas County, particularly in the watershed above 15 Trinidad reservoir. I forget the last count but I 16 believe there's over 8- or 900 coal bed methane wells. 17 And the impact on the water resources in the watershed is 18 beginning to be fairly significant. 19 There's some studies underway to determine how much 20 stream flow is being reduced by those wells. We had 21 initial estimates that it may be as much as 2,500 to 22 3,000 acre feet above Trinidad Dam. Well, that's 10 23 percent of our water supply. So we're looking at that
- 25 water quality. And so that's a major topic.

24

very closely. The other issue with coal bed methane is

1 We appreciate the effort Dennis Garcia is doing with 2 the Corps and the Bureau in terms of the channel capacity evaluation. You know, being an ex-bureaucrat, I'm never 3 enamored with the efficiency of government. The higher 4 5 you go up, the worse it gets. But we have a real good 6 effort between the Bureau and the Corps on this issue and 7 Dennis is really responsible for keeping that going. 8 It's important to the District. But it's also important 9 to Kansas and to people in the lower basin here because 10 when we capture water up there that can't be released, it 11 causes us administrative problems and it deprives people 12 of water down here that they are entitled. So we are 13 very interested in seeing the results of that study. 14 Now, whether we are going to have enough money to fix the 15 problem is another issue, but at least we know what the 16 problem is. 17 Water changes, as I said, in the watershed. 18 seeing more and more water move from agricultural use and 19 high use. Fourteen percent of the Model Land and 20 Irrigation Company has been purchased by the Division of 21 Parks and, you know, that's been two or three years ago, 22 but we are seeing changes in use as the basin develops. 23 One really fun project that the District got involved 24 with this year is called "Fishing for Fun". It's a 25 Division of Wildlife and a U.S. Fish and Wildlife program where they provide grant money, the District partnered 26

- 1 with the City of Trinidad. There is a lake called
- 2 Central Park Lake, which it didn't look like a lake. It
- 3 looked like a giant swamp full of cattails and stuff.
- 4 The whole point of it originally was to provide fishing
- for kids and for handicapped people. We went in and
- 6 cleaned that entire thing out, reshaped the banks, rip-
- 7 rapped it. And if you are ever in Trinidad, I would like
- 8 you to go over and take a look at it. It's a project
- 9 that I think we can really be proud of.
- 10 Ten-year review, I wasn't able to hear the report
- from the Bureau, but I think I know what he said. I
- 12 would encourage that process to move forward as rapidly
- as possible. We need to. I understand, you know, I
- 14 think the Bureau thought I would get up and rant and rave
- and scream and yell. At least Steve Miller stated I
- should do that. But I understand when people move on,
- 17 then things slow down. But I really would encourage the
- 18 Bureau to push that as fast as they can.
- 19 The last item I have is acreage verification. As
- 20 you know, under the Operating Principles, the District is
- 21 required to annually provide acreage verification in
- 22 terms of the amount of acres that are irrigated in the
- 23 project area. We have done that through a private
- 24 consultant for the last five years, I quess. We found
- 25 that the product we were getting was really not what we
- 26 wanted to provide to you and for our own purposes and so

1 we partnered with the Division of Water Resources, Steve 2 Witte's office in Pueblo, and we're looking at a whole 3 new procedure. I would ask Steve at this point to describe how we're going to hit them with that. Any 5 questions for me? 6 VICE-CHAIRMAN: Questions? Thank you, Jeris. MR. WITTE: Good morning again. As you know, 8 one of the more recent changes to the Operating 9 Principles has a provision in it, Article IV.B., to the 10 effect that the District implement substantive procedure 11 to verify each year that no more than 19,499, less the 12 municipal and Parks, dry up is irrigated each year and 13 that they will prepare the report that will include 14 tabulation showing the tracts and acreage location of the 15 lands irrigated. As Jeris indicated, we did enter into 16 an agreement this year where, first of all, we took the 17 acreage irrigation information that the District had, and 18 we put that into a GIS format that's compatible with the 19 standards that we have been using for acreage 20 verification on the Arkansas. So we got that information 21 plugged in so that we are reasonably confident of the 22 parcel boundaries and size and shape and that type of 23 thing. Then we conducted a parcel-by-parcel 24 classification. Well, what we propose to do is under 25 this agreement would be to have a parcel-by-parcel 26 classification utilizing interpretation of satellite

1 imagery on a five-year basis beginning with irrigation 2 year 2008. And that the District will conduct a random sample survey in 2008; and in the subsequent intervening 3 years to make estimations of the irrigated acreage. 4 5 The preliminary results we just got in, of course, we have until the -- District has until February to 6 7 submit their report for 2008, but I just wanted to report 8 that if you take the 19,499 acres that's defined in the 9 Operating Principles as being the direct irrigable area 10 and subtract off the 1,974 acres that have been dried up, 11 then that leaves 17,525 acres as being the threshold that the District should not exceed. And our preliminary 12 results indicate that there were 12,000 acres irrigated. 13 14 So well below that 17,000 figure that we're -- that the 15 District needs to demonstrate that it has stayed within. 16 So the plan of action moving forward will be to work with 17 a District to refine these numbers and to present the 18 type of tabular parcel-by-parcel identification and a 19 determination of whether or not using the satellite image 20 analysis whether those acreages were irrigated in 2008. 21 And those will be submitted before the February deadline. 22 That hasn't changed very much from the years past, except 23 I think you'll -- those who have requested that information will receive it in a GIS format that will 24 25 make your analysis or evaluation simpler. Then, each

- 1 year in the future, the District will survey about 20
  2 percent of the irrigable acres that are randomly
- 3 selected within the project to verify if it is irrigated.
- 4 Then the District will submit a report that will include
- 5 a projection of the actual irrigated acreage each year.
- 6 And then each fifth year we will do as we've done in
- 7 2008, and we'll do a complete District-wide analysis
- 8 using satellite imagery to provide a comprehensive report
- 9 for those fifth year reports. So that's the plan of
- 10 action moving forward. And I think you'll find it more
- 11 satisfactory than what's considered in recent years.
- 12 Questions?
- MR. HEIMERICH: I don't have any questions. I
- 14 do appreciate the efforts of the District working with
- 15 the Division to make improvements to the AVS. And I
- 16 quess I don't have any specific comments at this point,
- 17 but we'll obviously have a chance to review that work and
- 18 comment on it at the appropriate time, but -- Kevin, did
- 19 you have something?
- 20 MR. SALTER: Am I to understand you correctly
- 21 that for years two, three, four, five after this year,
- there will be just a projection of the irrigated acres
- 23 for the District?
- 24 MR. WITTE: There will be a projection of
- 25 irrigated acres based on random sampling from the

1 verification surveys that are conducted -- A 20 percent 2 of the parcels. 3 MR. SALTER: As I remember that requirement of 4 the Trinidad Operating Principles, it was to be tract-by-5 tract reporting of the irrigated acres in Purgatoire 6 District. So maybe we all need to take a look and see if 7 those projections are consistent with that provision. 8 MR. WITTE: I think it's important not to lose 9 sight of the fact that the District is irrigating 10 substantially less acres than is allowed under the 11 provisions of the Operating Principles. And so the 12 information that's available through the random sampling 13 surveys during those inner years seems as though it would 14 be adequately accurate for ensuring that the total 15 acreage irrigated is less than the amount allowed. 16 However, you know, if there is a need to have a parcel-17 by-parcel verification, there would be a means of doing 18 that. There may be other means of doing that to provide 19 that information. It just wouldn't be perhaps as 20 reliable as those 20 percent that the District would 21 commit to doing on the ground inspection of annually. 22 VICE-CHAIRMAN: Any other questions? I don't 23 have any. The only comment I have is on Jeris' noting 24 that Erma Evans had passed on. And as a personal note, 25 she hardly ever missed a Compact meeting, I don't

believe. So -- she'll be sorely missed. I'm thinking to

- 1 make a liar out of Jeris and we're going to eat the
- doughnuts up by 10:30 here. We're going to take a break
- 3 for about 15 minutes, and we'll convene about ten after
- 4 ten.
- 5 (There was a recess taken.)
- 6 VICE-CHAIRMAN: All right. I think we are
- 7 ready to get started again here. Might I remind you, if
- 8 you came in late, there was an attendance sheet that was
- 9 circulated, if you didn't get your name on that, please
- find one of those and get signed on that, please. We're
- 11 ready for number 9, report of Engineering Committee.
- Matt, is that you?
- MR. HEIMERICH: That's right, Randy. Thank
- 14 you. The Engineering Committee, which consists of myself
- and Chief Engineer Barfield, started off yesterday's
- 16 committee meetings and had a pretty full agenda. We
- 17 heard from several programs. Heard from the Corps on the
- 18 dredging operations at John Martin, channel flow issues;
- 19 capacity study down below the Trinidad Reservoir, on the
- 20 Purgatoire from Mr. Garcia; Ms. Van Pelt was here, and,
- obviously, we have heard detailed description of the
- joint projects between Colorado and Kansas on tamarisk
- 23 control. We also went over a few items that were on for
- old business, and we can probably go through those right
- now under the action items that the Engineering Committee

- developed. And if you don't mind, we'll just kind of go through those, Randy.
- 3 VICE-CHAIRMAN: Please do.
- MR. HEIMERICH: We obviously -- we started off 4 5 by rectifying, by instructing Steve Miller and Chelsea Juricek to go ahead and record our - the items and list 7 the action items for the Engineering Committee. 8 Committee did recognize that LAWMA (Lower Arkansas Water 9 Management Association) had withdrawn its request to put 10 -- for permanent pool water. That was actually a joint request with Department of Wildlife of Colorado. And we 11 12 want to thank Chief Engineer Barfield and the State of 13 Kansas for responding to Colorado's request to try to 14 capture what kind of issues they associated permanent 15 pool requests and what kind of suggestions they had for 16 possible source water for that permanent pool. So we are 17 requesting that the issue remain on the agenda for 2009, 18 and if there are subsequent requests from either LAWMA or 19 the Department of Wildlife, that those requests be 20 directed back to the Engineering Committee for its 21 review.

Last year we had received a letter and a request from the City of Lamar, represented by James Felt, looking at a source or using John Martin Reservoir as a source for their -- or I should say a terminal place for their Fry-Ark water, their allocation. Again, the State

1 of Kansas and Chief Engineer Barfield wrote a letter back 2 to Mr. Felt and copied Colorado on what kind of 3 requirements or what kind of conditions or recommendations they feel would be necessary for the City 4 of Lamar to obtain more or less -- I wouldn't call it 5 permanent, but perhaps a longer term storage in John 6 7 Martin Reservoir. The City of Lamar is taking those comments from Colorado under advisement. And we expect 8 9 to hear back from them sometime during the year. are also going to ask that that remain on the ARCA agenda 10 for 2009. 11 We went ahead - you heard from Mr. Edelmann. 12 made a very good report on the gages that are maintained 13 14 by ARCA. Again, we're just going to go ahead and see 15 what Pat and Bill and anybody else and if anything changes at the Big Sandy site, they will report that back 16 17 to the Compact Administration for a report next year. 18 And if there's any adjustments or changes to be made, 19 we'll do it at that time. 20 We went ahead and referred -- we deferred -- there was one issue that was under discussion, that was the 21 22 gage at the Lamar power plant, and we actually went ahead 23 and deferred that to the Administrative and Legal 24 Committee because it was more of a funding issue. I think it was a request to or changing that from a manual 25

reading station to a satellite reading station.

1 Ms. McDonald gave us a report on the status of the 2 Tri-State Generation change case, and we would request 3 that that issue remain on the agenda for Compact Year 4 2009. 5 State Engineer Dick Wolfe gave us -- gave the Committee a briefing on the proposed irrigation 7 consumption rules, which I believe now Kansas has in 8 their possession for review. There was some questions 9 asked; and, again, the Engineering Committee is going to 10 ask that it remain on the agenda -- ARCA's agenda for 11 2009. 12 We're also going to recommend, and I think it will 13 come under item 14.B -- I believe it's B -- No. 14.A, the 14 Engineering Committee will recommend that ARCA approve 15 and sign the Tamarisk Joint Resolution, and we'll also go 16 ahead and I'm going to read this verbatim. I think it's 17 the best way to do it. 18 "The committee recognizes the value of the Special 19 Engineering Committee and recommends to ARCA that the 20 Special Engineering Committee be extended for the 21 calendar year 2009 in order to evaluate unresolved issues 22 as well as new issues put before the Special Engineering 23 Committee." David, do you have anything to add to that? 24

MR. BARFIELD: I do not.

1 MR. HEIMERICH: And on a personal note, I 2 would like to thank David and the State of Kansas for 3 their cooperation on those two issues: The John Martin 4 Reservoir permanent pool and the request of the City of 5 Lamar. I know we're going to get to it later on in the year, that we're going to change chairmanships and I want to wish David the best in leading the Engineering 7 8 Committee in 2009. 9 MR. BARFIELD: Well, thank you. It's 10 important to continue to work with you on these issues. 11 MR. HEIMERICH: Thank you, Mr. Chairman. 12 VICE-CHAIRMAN: Thank you, Matt. This I 13 assume will be made as an attachment? 14 MR. HEIMERLICH: Excuse me. Steve, signatures 15 will all be later or do David and I need to sign this 16 actually now? 17 MR. MILLER: Just before we leave today. 18 MR. HEIMERLICH: Okay. So we have to make 19 sure we sign things. Okay. Thank you, Mr. Chairman. 20 VICE-CHAIRMAN: Thank you. Operations 21 Committee, Dave. Chaired that as your report. 22 MR. BRENN: I'm David Brenn. The Operations 23 Committee met yesterday afternoon. And I'm going to 24 confine my comments to the action items, as we're all sensitive to time today. And some of these issues will 25 26 be dealt with subsequent in the agenda. We did instruct

1 Steve Miller and Chelsea to report a list of action items 2 before the meeting. As part of our dialogue, the Committee determined to recommend continuing dialogue 3 between the Operations Secretary and the Assistant 5 Operations Secretary. Regarding the Pueblo Winter Water 6 Storage split and permanent pool deliveries as was 7 described in the August 2004 dispute resolution procedure, both are to report back to the Operations 9 Committee on this issue at a future date. The Committee received the 2008 reports from the Operations Secretary 10 and Assistant Operations Secretary. The Committee also 11 12 received the 2008 report for the Offset Account. Committee recommends to ARCA to accept the calendar year 13 2008 Water Issues Matrix as included in the calendar year 14 15 2008 Assistant Operations Secretary report. 16 Additionally, the Committee instructs Steve Witte and 17 Kevin Salter to add the reservoir to reservoir deliveries 18 issue to the calendar year 2009 Water Issues Matrix. 19 Committee recommends that the Administrative and Legal 20 Committee revision of the 1980 Operating Plan be reviewed by both States for approval at the calendar year 2009 21 22 ARCA meeting. There's been significant work on those 23 revisions, but Kansas needs an opportunity to further 24 look at those revisions; and, hopefully, we can get that taken care of in the future. The Committee recommends to 25 26 ARCA that the Special Engineering Committee be extended

for calendar year 2009 in order to evaluate unresolved 1 2 issues as well as new issues put before the Special Engineering Committee. Committee also recommends 3 consideration be given to including the ten-year Compact 4 5 compliance table within the ARCA annual reports pending the States' review of the Compact compliance table. 6 7 Committee requests the Special Engineering Committee meet to review Recommendation G, and recommend action to ARCA 8 9 on the Offset Account and this will be further covered in a later agenda item. If the need arises, the Committee 10 will hold a meeting in April to mid-summer 2009 at a date 11 12 and time and location to be announced. And that 13 completes my report, Mr. Chairman. VICE-CHAIRMAN: Thank you. Colin, do you have 14 15 anything to add to that? 16 MR. THOMPSON: No. 17 MR. BRENN: And, Mr. Chairman, if I could, 18 it's a joy to work with Colin Thompson on this Committee, 19 and I certainly wish him well next year as chairman of 20 this Committee, one job that I know you cherish and look 21 forward to. But it is kind of great. We sometimes 22 appear pretty stiff and disciplined up here. But it's 23 great to be able to work with people you can talk to on issues, and I think we have got a good thing there. 24

MR. HEIMERICH: Yeah, works good.

VICE-CHAIRMAN: Thank you. Make that as an 1 2 attachment to the meeting, the report of the Operations 3 Secretary. Steve, do you have a report for us today? 4 MR. WITTE: Mr. Vice-Chairman, as was reported 5 a moment ago, I did tender my report to the Operations 6 Committee yesterday, which they have accepted. I have 7 also delivered a copy of this to Stephanie Gonzales for 8 ARCA's records. I'll defer to you as to whether you want 9 to give me a summary of the report for the benefit of the 10 audience or whether just to move on at this point in the 11 interest of time. 12 VICE-CHAIRMAN: I think just in the interest 13 of time since you gave the report last night, maybe just 14 hit the highlights if you can. 15 MR. WITTE: Very well. During the Compact 16 Year 2008 which began November 1st, 2007, the period of 17 winter storage commenced on November 1st and extended 18 through April 14, during which time a little over 29,000 19 acre feet was stored. Beginning November 16, we began 20 inflows of the type of water that would be stored under 21 Section III. Ultimately, 14,369 acre feet was 22 transferred into Section III accounts. That was the 65 23 percent portion and then the 35 percent portion was 24 distributed pursuant to the provisions of Article or 25 Section III.D of the 1980 Operating Plan.

1 One operation that occurred in 2008, which was 2 somewhat out of the ordinary, is that pursuant to an 3 agreement between the States through the Special 4 Engineering Committee, we acted to make a delivery of 5 3,062 acre feet of water purchased through the Lower 6 Arkansas Valley Water Conservancy District utilizing, 7 ultimately utilizing some funds available from the 8 Colorado Water Conservation Board as a means to make 9 restitution for past deliveries, under deliveries to the 10 State of Kansas that occurred during the period 1996 11 through 2005. And that delivery was made to the Kansas 12 Section II account during the month of May. That will be 13 addressed in the resolutions I think the Administration 14 will take under consideration later today along with some 15 other provisions of that resolution. Just report that we 16 added 3,876 acre feet to the permanent pool during the 17 year. 18 Kansas called for deliveries out of its account 19 totaling 14,122 acre feet. Using the crediting 20 agreements that have been reached between the States, we 21 are in agreement that there was no under delivery on 22 Section II accounts in 2008. Additionally, then, I wanted to report that the City 23 24 of Lamar did call for a release of 918 acre feet of Fry-25 Ark Project water to be released from Pueblo Reservoir 26 after assessing transit losses, which we delivered

- 1 through John Martin Reservoir as a bypass operation about
- 2 824 acre feet, which was then subsequently delivered to
- 3 the Fort Bent Canal for later delivery to the Clay Creek
- 4 well field.
- 5 There were two events during the year where water
- 6 was added to conservation storage after the period of
- 7 winter storage. One event, we had added to conservation
- 8 storage about 14,571 acre feet. Later in October we
- 9 added another 5,700 acre feet. There was one event
- during the year which caused the Amity Canal to be
- 11 entitled to store additional water during the summer
- 12 storage season into its Section III account amounting to
- about 4,650 acre feet; and, of course, there was a
- 14 transit loss
- 15 component that was deducted prior to the delivery into
- 16 the Section III account.
- 17 So at the end of the year, we had about 32,655 acre
- 18 feet in the reservoir, and other than to note some
- 19 activities by the Operations Committee where staff
- 20 members met throughout the year and to report on the
- 21 actions of the Special Engineering Committee, that was
- the substance of my report.
- VICE-CHAIRMAN: Thank you. Anybody have
- 24 questions for Steve?
- MR. THOMPSON: That was quite a set of
- 26 highlights there, Steve.

1	MR. WITTE: Yeah.
2	VICE-CHAIRMAN: Kevin, do you have an
3	Assistant Operations Secretary report?
4	MR. SALTER: Yes, I do. And I'll be brief. My
5	name's Kevin Salter. I'm the Assistant Operations
6	Secretary for the Compact. I want to I provided a
7	report last night to the Committee for the Kansas
8	perspective on operations that occurred this year. Glad
9	to report that we do not find any new concerns to raise
10	this particular year with the operations. I do want to
11	commend the Operations Secretary Steve Witte and his
12	staff for the level of communication that we have had
13	between his office and ours on various operations that
14	occurred during the year.
15	One thing I did do in my report is just kind of
16	document with a graph the operations of the Pueblo Winter
17	Water Storage Program that had occurred through the
18	Arkansas at Las Animas gage. The graph shows the Compact
19	share of the water as compared to the total flow and then
20	also has the split ratio that occurred between those two.
21	The split ratio has been a concern between the States.
22	Steve Witte characterized deliveries to the State of
23	Kansas, and then one thing I would note as far as H-I
24	Model goes, there's some transit loss inputs that go into
25	the H-I Model that I haven't fully checked yet, but
26	intend to do that prior to the H-I Model rup

Steve covered the deliveries to John Martin 1 2 Reservoir permanent pool. We did that also and we provided that to Steve for inclusion of his report of 3 pass through accounting status of the reservoir throughout the year. I appreciate Steve including that 5 6 in his report. 7 He did mention the two meetings between the staffs. We did have a teleconference on November 18th, which I 8 think was adequate for the time, but it still doesn't 9 10 meet sitting across the table and discussing the items. In his report, he included the written summary for the 11 12 May meeting; my report included the written summary for 13 the November meeting. The water matrix issues have been touched on. 14 So 15 that kind of summarizes my report in brief. VICE-CHAIRMAN: Okay. Thank you, Kevin. 16 Anybody have questions for Kevin? Comments? Thanks, 17 18 Kevin. The Offset Account report? Is that you again, 19 Bill? 20 MR. TYNER: I'm Bill Tyner with Colorado 21 Division of Water Resources. The highlights in the Offset Account report for Compact Year 2008, the account 22 23 in John Martin Reservoir used for replacement of the well 24 depletions was funded with a storage charge by the Lower Arkansas Water Management Association to fulfill the 500 25 acre feet storage charge and 10,000 acre feet of initial 26

1 storage. The LAWMA, Lower Arkansas Water Management 2 Association was the only association that used the Offset 3 Account this year. They delivered over 18,000 acre feet 4 of consumable water to the Offset Account. So once they 5 hit the 10,000 acre foot limit of that original storage 6 charge, five percent of what they delivered goes into a 7 Kansas charge account for the rest of the deliveries, 8 about 10,000 acre feet. I might point out that of those 9 flow figures that Pat Edelmann gave you earlier in the 10 meeting, I believe you had something on the order of 11 200,000 acre feet of flow through the Stateline gages. 12 And the Offset Account delivery that Kansas was able to 13 take during this year represented about 14,000 acre feet 14 of release out of John Martin and resulted in 11,617 acre 15 feet of consumable delivery to the Stateline plus some 16 additional water that arrived at the Stateline. LAWMA 17 also provided direct replacement sources to the river 18 that totaled close to 5,000 acre feet during that period. 19 So just to put that in context, a couple hundred 20 thousand acre feet that Pat reported having arrived at 21 the Kansas Stateline, that well replacement water is 22 about ten percent of that total flow. And I think I had 23 seen Mr. Barfield quoted in the Kansas paper talking 24 about not only was Kansas pleased with the financial 25 damage repayment that they got, but that the real benefit 26 to western Kansas was that water supply was restored,

those depletions were being replaced. I think that's 1 2 noteable that LAWMA and the other Colorado well associations -- the Colorado Water Protective and 3 4 Development Association and Arkansas Ground Water Users 5 Association -- by making those replacements in time and location and the amount, keep the river whole and that 6 7 preserves the river for both Colorado and Kansas water 8 rights. 9 The Colorado irrigation well pumping during the 10 Compact Year increased quite a little bit from the last few years. Well pumping had been down following the 11 12 drought period beginning in 2003 and continuing through 2007. But during the Compact Year of 2008, the pumping 13 14 rebounded a little bit to approximately 88,000 acre feet 15 of irrigation well pumping. In order to support that 16 pumping, Colorado well associations did dry up 17 approximately 9,800 acres below John Martin Reservoir, 18 7,200 acres above John Martin Reservoir and used those 19 direct flow irrigation water rights to augment the river 20 and allow well pumping the Colorado farmers wanted to 21 And as has been previously mentioned, the ten-year 22 Compact compliance accountings for 1998 through 2007 is the ultimate measure of how well Colorado's well 23 24 association plans, including the use of the Offset 25 Account, perform and we're in excess of 18,000 acre feet 26 on a surplus in that with respect to that measure. So

- 1 that's good news, I think, for both Colorado and Kansas.
- 2 Thank you. Any questions?
- 3 VICE-CHAIRMAN: Okay. Thank you, Bill. Ready
- 4 to move on to number 11. That's the report of the
- 5 Special Engineering Committee. Dave Brenn, is that you?
- 6 MR. BRENN: I can do that. Just a bit of
- 7 background for those who maybe are new to our meeting
- 8 here. The Special Engineering Committee was formed in
- 9 December of 2005 by ARCA. Its purpose was to address a
- 10 number of unresolved issues related to the accounting of
- John Martin operations under the 1980 Plan that has sort
- of accumulated over the years prior to that time.
- 13 Special Engineering Committee was composed of, initially
- anyway, the former State Engineer for Colorado, Hal
- 15 Simpson, and former Chief Engineer for Kansas, David
- Pope, and their staff, and then another member of the
- 17 Administration in addition, Rod Kuharich, David Brenn. A
- 18 little bit of changes in staffing of the Committee --
- 19 composition of the Committee over the years as a result
- of retirements -- but anyway, that Committee has worked
- 21 pretty diligently over the years and provided
- 22 recommendations to ARCA to resolve the issues -- and of
- 23 the 23 issues that the Committee was provided initially,
- 24 I think 23 have had some recommendation for resolution to
- 25 ARCA.

Now since that time we sort of added more issues. 1 But, anyway, it's made a lot of progress. This year the 2 Committee finalized a recommendation May 1st that's being 3 4 provided to ARCA for the consideration of potential 5 action on it. I won't go through all the provisions of that, but just in brief, prior to this time, we had 6 7 agreed upon methods to determine crediting under the 8 Offset Account deliveries as well as Section II 9 deliveries and we agreed to take those methods and apply them to the period 1996 and forward, and the States then 10 applied those and eventually agreed to the numbers. 11 12 noted some deficits on deliveries to Kansas, Section II 13 that accumulated and agreed upon as Steve Witte 14 mentioned, a certain amount of water to be delivered to 15 replenish Kansas Section II. So, anyway, Recommendation 16 G sort of memorializes all of that and basically paves 17 the way for the approvals of the Operations Secretary's 18 reports that's been sort of hanging there over all of 19 those years and eventually the annual reports as well. 20 The recommendation has some language for proviso language 21 to be sort of put on the reports of the Operations 22 Secretary to note that we have agreed to some changes. 23 So that's in essence what recommendation G that the 24 Special Engineering Committee provided to ARCA officers. And I think we'll have action on that recommendation 25 26 later on in this new business.

1	VICE-CHAIRMAN: COILECC.
2	MR. BRENN: I guess I'll go ahead and speak to
3	agenda item 11.B, continuation of the Special Engineering
4	Committee. Again, we have resolved a lot of the issues
5	that are out there, but there's still a few remaining
6	that were in the original 2005 matrix. And I think three
7	have been added since then, and I think we added another
8	one last night. I think it's a sense of both States that
9	that Engineering Committee should continue to work this
10	coming year on some of the specific items that are still
11	outstanding. And, again, I believe there will be
12	resolution to that effect later.
13	VICE-CHAIRMAN: Okay. Any other members of
14	the Special Engineering Committee have anything to say at
15	this time? Okay. Thank you. Next report comes from our
16	newest members of the Compact Administration. I should
17	have welcomed you in the very beginning, but we're glad
18	to have you as a member for the Compact, Jennifer. Do
19	you have the Administrative and Legal report?
20	MS. GIMBEL: I do. It's so nice to be here in
21	Lamar and to be meeting with my Kansas friends again. So
22	I am really enjoying this meeting. The Administrative
23	and Legal Committee looked at the Lee Rolfs resolution,
24	recommended adoption, which we have already done. We
25	also looked at and we will be recommending approval of
26	the audit report for the fiscal year 2007 to 2008. We

1 recommend that the Administration authorize the amended 2 satellite contract. And that they approve gage contracts 3 with Kansas and Colorado sections of the USGS. 4 Committee also recommends to ARCA that Stephanie Gonzales 5 sign the approved budget and assessments for the current 6 fiscal year 2008. Mr. Chair, I would note that we would do -- we have 7 on the agenda all of those items except in 14.C, but we 8 9 don't have the authorization for the amended satellite 10 contract and gage contract so we need to add that. I apologize for not catching that earlier. With respect to 11 12 the minutes of transcripts, the Kansas and Colorado staff 13 will continue to keep finalizing the meetings and 14 transcripts. 15 The Committee approved the slate of officers and 16 Committee chairman for 2009. Those recommendations are: 17 Officer to be vice-chair Randy Hayzlett; Recording 18 Secretary and Treasurer Stephanie Gonzales; Operations 19 Secretary Steve Witte; and Assistant Operations Secretary 20 Kevin Salter. 21 The Committee chairs for 2009, Engineering David 22 Barfield; for Operations Colin Thompson; and for 23 Administration and Legal, myself, Jennifer Gimbel. 24 The Committee also recommends that we look at both 25 Kansas and Colorado, look at proposed revisions to the 26 1980 Operating Plan and with the goal of approving those

- 1 at our 2009 meeting. And we also agree with the
- 2 recommendations by the other Committee of extending the
- 3 Special Engineering Committee. And that's my completed
- 4 report.
- 5 VICE-CHAIRMAN: Thank you. We will make that
- as another attachment to this meeting, and we'll get
- 7 signatures on that. We did neglect to get the agreement
- 8 with the USGS on this agenda. So we will take care of
- 9 that when we get into new business. Stephanie, do you
- 10 have a report for us?
- MS. GONZALES: Just a couple of things.
- 12 First, I want to take the opportunity to apologize for
- the delay in the coffee this morning. I'm trying to get
- 14 used to the coffeemaker back there. We'll work on that
- 15 for next year.
- 16 Last evening I reported that I have the USGS Joint
- 17 Funding Agreement from Colorado. I have received it.
- 18 Apparently, there was a little mix-up at the post office,
- 19 but I do have that.
- 20 And, finally, I had a really great suggestion from
- 21 Mr. Heimerich last evening regarding the archiving of the
- 22 ARCA records. And he suggested to me that I possibly
- 23 contact Lamar Public Library for an area that maybe we
- 24 can set up for reference. And we'll work on that this
- year and see what we come up with. I thought that would
- 26 be a great way to do it as well, just helping to make

- that more accessible. And that's all I have to report.
- 2 Thank you.
- 3 VICE-CHAIRMAN: Very good. Thank you. I have
- 4 item 13 as old business. Is there any old business to
- 5 come before the committee?
- 6 MR. BARFIELD: Not that I'm aware of.
- 7 VICE-CHAIRMAN: Hearing none, we're moving in
- 8 to new business. Most of these are action items that we
- 9 need to take action on. Item A is assignments to and
- 10 action of the recommendations of the Engineering
- 11 Committee. First item on that is a resolution on the
- 12 tamarisk control. Do you have that?
- MS. GIMBEL: And would you -- I'm not sure
- 14 about protocol -- would I read the resolution into the
- 15 record or is just explaining what the record --
- 16 VICE-CHAIRMAN: I think read the resolution
- 17 probably into the record and the letter there is
- 18 supported.
- MS. GIMBEL: I would note that we have -- that
- 20 Robin Jennison copied a bunch of us, all of us up here,
- 21 has sent a letter to the Administration endorsing a
- 22 resolution to formalize the cooperative efforts for
- 23 tamarisk control between the States of Colorado and
- 24 Kansas. And that, on an editorial note, just shows and
- 25 acknowledges the cooperation between these two States on
- those sorts of issues.

1	VICE-CHAIRMAN: Jennifer, did you say Robin
2	Jennison sent that?
3	MS. GIMBEL: I see it's to Robin Jennison.
4	It's from Tim Carlson of the Tamarisk Coalition. The
5	resolution I propose is concerning joint effort by the
6	State of Colorado and the State of Kansas in pursuit of a
7	tamarisk control and watershed restoration program using
8	a regional approach. And I'll read the resolution:
9	"Whereas, tamarisk is an exotic plant species that
10	is invasive due to its prolific reseeding and extensively
11	deep root system; and
12	"Whereas, tamarisk has reproduced rapidly, invading
13	over 78,000 acres within the Arkansas River Basin of
14	Colorado and Kansas; and
15	"Whereas, tamarisk infestation had diminished the
16	habitat of plant and wildlife; and
17	"Whereas, it is recognized that tamarisk acts as a
18	fuel ladder creating higher fire dangers; and
19	"Whereas, tamarisk causes the narrowing of river
20	channels posing extreme flooding danger; and
21	"Whereas, tamarisk is a phreatophyte species that is
22	impacting the limited water resources in the over-
23	appropriated Arkansas River Basin; and
24	"Whereas, this tamarisk infestation is not limited
25	to just one watershed or just one State and any tamarisk

1 control project should not be limited by State 2 boundaries. 3 "Now, therefore, be it resolved that the Arkansas 4 River Compact Administration supports the States of 5 Colorado and Kansas in pursuing funding through Public 6 Law 109-320, The Salt Cedar and Russian Olive 7 Demonstration Act, and other Federal funding to fund a 8 joint tamarisk control and watershed restoration project 9 in the Arkansas River Basin." 10 Adopted by the Compact Administration this 9th day of 11 December. 12 And I would so move. 13 VICE-CHAIRMAN: Thank you. Second? 14 MR. BARFIELD: Second. 15 VICE-CHAIRMAN: Discussion? No discussion. 16 Colorado vote? 17 MR. HEIMERICH: Colorado votes aye. 18 VICE-CHAIRMAN: Kansas? 19 MR. BARFIELD: Kansas votes aye. 20 VICE-CHAIRMAN: Motion carried. I attached 21 those. Kevin has a question? 22 MR. SALTER: I'm just asking that would be 23 ARCA Resolution 2008-2. 24 VICE-CHAIRMAN: Okay. Thank you. 25 MS. GIMBEL: Mr. Chairman, amusing editorial.

VICE-CHAIRMAN: Yes.

1 MS. GIMBEL: I live in a subdivision called 2 Tamarisk, so we thought that was appropriate. 3 VICE-CHAIRMAN: Thank you. And after it's 4 eradicated, you will no longer live there. Next item is 5 assignments to an action of recommendation from the Operations Committee. Resolution there, David, do you 6 7 have that? 8 MR. BARFIELD: Yes, I do. As we mentioned, 9 Recommendation G was provided by the Special Engineering 10 Committee to ARCA. And we have a resolution that the 11 States have sort of worked out essentially adopting all 12 the various matters in that recommendation save one. Let 13 me offer -- let me read the recommendation we would like 14 to offer. It's entitled: Action on Special Engineering 15 Committee Recommendation G. 16 "Whereas, the Arkansas River Compact Administration 17 created a Special Engineering Committee by means of Resolution No. 2005-1 and directed the Committee to 18 19 develop recommendations to ARCA to reduce or eliminate 20 disputes between the States and ARCA extended the term of 21 the Committee by Resolution Nos. 2006-7 and 2007-4; and 22 "Whereas, Colorado has delivered 3,062 acre-feet to 23 Kansas Section II account as restitution for the past 24 deficits accumulated during Compact Years 1996 through 25 2006 in accordance with paragraph c of Recommendation G 26 of the Special Engineering Committee attached hereto.

1 "Now, therefore, be it resolved that the 2 Administration hereby adopts the recommendations in the 3 attached Recommendation G of the Special Engineering 4 Committee except that all references to the Reports of 5 the Colorado State Engineering concerning Accounting of 6 Operations of an Offset Account in John Martin Reservoir 7 for Colorado Pumping are excluded from approval by this 8 Resolution, and except that the proviso be added to the 9 cover page of each Annual Report of the Operations 10 Secretary referred to in paragraph A.3 of Recommendation 11 G shall be modified to read as follows: 12 "The Annual Reports of the Operations Secretary for 13 Compact Years 1994 through 2005 have been approved 14 by the Arkansas River Compact Administration with 15 the following proviso: The values and operations in this report have been in dispute. An addendum report, dated December 9, 2008, contains the revised values that have been determined through agreement by the States. However, while Kansas and Colorado have agreed that the accounting prior to 2006 will

not be otherwise revised, Kansas does not waive any

1 "Be it further resolved that the subject of Offset 2 Account Reports is hereby referred to the Special 3 Engineering Committee for further consideration; and 4 "Be it further resolved that the addendum referred 5 in paragraph A.1 of Recommendation G is attached hereto 6 and is entitled, quote, Addendum to the 1994-2005 Reports 7 of the Operations Secretary, closed quote, dated December 8 9, 2008." Adopted today by ARCA. 9 So this resolution would essentially adopt all the 10 recommendations in Recommendation G except for actions 11 related to the Offset Account reports. The primary 12 purpose of Recommendation G, you know, was sort of 13 adopting, making the way for the adoption of the 14 Operations Secretary report, the annual reports, 15 recognized the restitution that Colorado did provide to 16 the State of Kansas for past deficits and so forth. We 17 need to do a little more work with respect to -- well, 18 let me back up. Part of those accountings dealt with 19 Offset Account crediting as well. We just need to do a 20 little more work in terms of how that fits with the 21 Offset Account reports and what actions are appropriate 22 for ARCA to take with respect to the Offset Account 23 reports. 24 And so -- unless there's questions, I guess I would 25 offer this resolution for adoption by ARCA. 26 VICE-CHAIRMAN: Second?

- 1 MR. HEIMERLICH: Second.
- 2 VICE-CHAIRMAN: Discussion? Hearing none. Colorado
- 3 vote?
- 4 MR. HEIMERICH: Colorado votes aye.
- 5 VICE-CHAIRMAN: Kansas?
- 6 MR. BARFIELD: Kansas votes aye.
- 7 VICE-CHAIRMAN: Motion carried. Resolution
- 8 will be offered.
- 9 MR. BARFIELD: That will be Resolution 2008-3.
- 10 And I have attachments Recommendation 3 on the
- 11 appropriate addendum table.
- MR. SALTER: A little housekeeping. We did
- have four original copies; if we could have those four
- 14 originals turned in to the front desk and make sure they
- 15 all get signed.
- MR. MILLER: I would like to make that for all
- 17 the resolutions. If the reporter can just hang onto
- 18 everything that's at her front desk. We'll get this
- 19 squared away. The resolutions we have done, I believe,
- 20 are -- Some of those are resolutions and some of them are
- 21 just exhibits.
- MR. HEIMERICH: Mr. Rolfs is No. 1; 2 is
- tamarisk; 3 is Recommendation G.
- MR. MILLER: We'll help you sort it out after
- we're done.

VICE-CHAIRMAN: Item 2 under B is 1 2 recommendation on past Operations Secretary reports. Who has anything on that? Anything, Steve? 3 MR. MILLER: I think the resolution that we 4 5 just adopted takes care of 2006. The status of 2007 and 2008 remain uncertain and unresolved. And I don't know 6 if this would be the place to do it. Were you wanting to 7 address that or not? We're starting a backlog again if 9 we don't do something about '07 and '08. MR. BARFIELD: I'm not sure what the intent 10 Obviously, the action we did just take in adopting 11 12 Recommendation G was put on record ARCA's approvals 13 through 2006. Is that what this item was about? 14 MR. SALTER: That's what I was going to say. Steve Witte may want to address 2007, 2008; other than I 15 16 understood kind of the process Operations Committee did 17 last night. 18 MR. WITTE: David may want to speak to this as 19 well. But the discussion at the Operations Committee 20 meeting last evening was that this subject of approval of 21 reports after 2006 will be considered by a future meeting 22 of the Operations Committee. I think that's all there is 23 to report at this time. MR. BRENN: Mr. Chairman, I think it's timely 24 25 to note that this Recommendation G was a huge positive 26 step between States in addressing those issues; and it

1 was also commented that certainly should be no intent 2 that we establish a precedent of backlog and that through 3 open and transparent dialogue between the States, we can 4 deal with these things in a timely manner. 5 VICE-CHAIRMAN: Any other comments? 6 The next item was one that was added to the agenda. It's 7 B.3 which is the recommendation on the ten-year 8 accounting or review of the ten-year accounting. We had 9 some discussion about that last night. Some follow-up on 10 that. Who wants to comment on that? 11 MR. BARFIELD: I think I'll go ahead and 12 attempt to address it, I guess. It was suggested I think 13 last night in one of the committee meetings that it may 14 be appropriate for ARCA to attach the ten-year 15 accountings once all of the States have gone through that process of reviewing the operations and the offset 16 17 operations and crediting and H-I Model runs and all that 18 for ARCA to consider maybe attaching those to its annual 19 reports. I think it's a good suggestion, and we need to 20 sort of consider sort of the process by which that's 21 reviewed, approved by the States and sort of how it gets 22 into the records. We are willing to consider that 23 suggestion. I don't know who wants to sort of figure out 24 the process or sort of how that happens. Can the 25 Operations Committee figure that out? We are certainly

willing to consider that.

1 VICE-CHAIRMAN: Okay. Any comments on that 2 item? 3 Is that a motion? I mean, are MS. GIMBEL: you putting this off until 2009? 4 5 VICE-CHAIRMAN: I was thinking that we would like the Operations Committee to look at that in their 6 7 summer/spring meeting. 8 MR. MONTGOMERY: Could I just make a comment 9 on their reason for including a ten-year accounting in 10 ARCA's annual reports? The proposed decree that has been 11 submitted by the Special Master includes a provision for 12 the State's agreeing on H-I Model results in the ten-year 13 accounting. And that process is Colorado provides that 14 accounting to Kansas by March 31st; Kansas provides its 15 response by I believe it's May 15th; and the States are 16 to agree by June 1st. Can be updated at a later time 17 based on obtaining final crop statistics. But Colorado 18 felt it would be important to document the agreement of 19 the States' ten-year accounting somewhere and see that 20 the ARCA annual reports were the most appropriate place 21 to include what the States have agreed to. 22 VICE-CHAIRMAN: Wasn't the question as to how 23 current the data was for each annual report? How to deal 24 with that issue? 25 MR. SALTER: Yes. I understand the Operations 26 Committee will address that issue, but it will always be

- 1 a year behind because the H-I Model results are always
- one year behind.
- VICE-CHAIRMAN: Okay. I don't know that
- 4 there's any action required on that item at this point.
- 5 Questions?
- 6 MR. BARFIELD: Yes. I guess I would propose -
- 7 again, this suggestion came up last night. We think
- 8 it's a good one. Sort of figure out the form and all of
- 9 that, and I guess I would recommend we assign this to the
- 10 Operations Committee to sort of figure out the process
- 11 and all the particulars about how we go about -- how we
- do it and the form of it and such things. So --
- 13 VICE-CHAIRMAN: Steve?
- MR. MILLER: I have reports later on in the
- 15 agenda but this might be the best place to disclose it.
- 16 I think that's a good tactic, and I probably will need
- 17 some place to send my draft reports as they start issuing
- 18 out with the passage of Resolution No. 3; and over the
- 19 times since the last time we published in '93, there has
- 20 been several changes to operations and changes to the
- 21 status of the case. So make it more instructional a
- little bit and authorize me to work with the Operations
- 23 Committee on a variety of new issues that annual reports
- 24 will need to address as we move forward. And then, of
- 25 course, those reports don't become final until the full
- 26 Administration reviews it in some fashion. But If I can

- 1 get, test out new paragraphs that will deal with the
- 2 Offset Account, the compliance accounting, and things
- 3 with the Operations Committee, and then when they're
- 4 comfortable, we'll bring it before ARCA.
- 5 VICE-CHAIRMAN: Okay.
- 6 MR. BARFIELD: Why don't we just handle this
- 7 under agenda item 14.C.6 then. And we'll just include it
- 8 in those provisions, if that's okay.
- 9 VICE-CHAIRMAN: Okay. I believe that brings
- 10 us to 14.C.1, the assignments and action from the
- 11 Administrative Legal Committee, the election of officers.
- 12 As we -- Jennifer recorded -- you don't have those down
- 13 there?
- 14 MS. GIMBEL: I don't have those names down.
- 15 VICE-CHAIRMAN: The election of officers for
- the coming year would be Vice-Chair Randy Hayzlett;
- 17 Operations Secretary Steve Witte; and Assistant
- 18 Operations Secretary Kevin Salter. And do we have
- 19 Stephanie on that? Stephanie Gonzales?
- MS. GIMBEL: Yes.
- 21 VICE-CHAIRMAN: Stephanie Gonzales is
- 22 Recording Secretary and Treasurer. Do I hear a motion
- for those positions?
- MS. GIMBEL: So move.
- 25 VICE-CHAIRMAN: Second?
- MR. BRENN: Kansas second.

1	VICE-CHAIRMAN: It's been seconded. Any
2	discussion? If not, Colorado vote?
3	MR. HEIMERICH: Colorado votes aye.
4	VICE-CHAIRMAN: Kansas?
5	MR. BARFIELD: Kansas votes aye.
6	VICE-CHAIRMAN: Motion carried. Appointment
7	of committee chairs for the '09 year, we have David
8	Barfield for Engineering chair; Colin Thompson for
9	Operations chair; and Jennifer Gimbel for Administrative
10	and Legal. I assume we need a motion on that?
11	MR. HEIMERICH: So moved.
12	VICE-CHAIRMAN: Seconded?
13	MR. BRENN: Second.
14	VICE-CHAIRMAN: Any discussion? If not,
15	Colorado vote?
16	MR. HEIMERICH: Colorado votes aye.
17	VICE-CHAIRMAN: Kansas vote?
18	MR. BARFIELD: Kansas votes aye.
19	VICE-CHAIRMAN: Motion carried. Now we're
20	ready for the approval of the audit report. Do you have
21	any more comments on those or anything to take us
22	through, Steve?
23	MR. MILLER: No. I reviewed both the audit
24	and the budget actions that need to be ratified. These
25	are unsigned versions of the things I'm going to talk
26	about. There's one for the reporter. Before we leave if

1 you can approve of these things, I got clean originals to 2 sign as well. 3 MR. HEIMERICH: So Susan gets one copy of each 4 package now before we write on it. 5 MR. MILLER: I have got more originals if I 6 need to make a new original. But there should be enough 7 for everybody at the front of the table. One of the 8 handouts is an audit report for the year '07-'08. We 9 reviewed that, we noted a new process in the budget in 10 there, but the audit itself is fine. And the Committee 11 recommended approval. So I would ask that by motion, 12 ARCA approve the audit and authorize Randy as Vice-13 Chairman to sign the clean originals that I'm holding at 14 the end of the meeting. We'll make that part of the 15 permanent records of ARCA. 16 VICE-CHAIRMAN: Do I hear a motion from 17 anybody? 18 MR. BARFIELD: So move. 19 VICE-CHAIRMAN: Seconded? 20 MR. HEIMERICH: Seconded. 21 VICE-CHAIRMAN: Moved and seconded. Any more 22 discussion? In Colorado vote? 23 MR. HEIMERICH: Colorado votes aye. 24 VICE-CHAIRMAN: Kansas votes? 25 MR. BARFIELD: Kansas votes aye.

VICE-CHAIRMAN: Motion is carried.

1 MR. MILLER: Next, we reviewed the current 2 year's budget and noted that our reserve account will be slightly lower than what we expected. But there was no 3 reason to change the budget for '08/'09. The handouts 4 5 include a proposed revised budget for '09/'10, and we are revising that so that we do better reflect our actual 6 7 reserve position at the end of that fiscal year. I don't 8 know if you want to adopt the two -- there's two budgets 9 there. Maybe we should just adopt that one for right now. It would be the first revision to the 2009/2010 10 budget showing the total expenditures, estimated 11 12 expenditures of \$84,800. 13 MR. BARFIELD: Why don't we just do them both? 14 MR. MILLER: Do them both? Okay. The other 15 budget action that needs to be taken then would be the 16 adoption of a budget for the fiscal year 2010 through 17 2011. That budget again is in front of you and has a total expected expenditures of \$89,500. In both cases 18 19 the assessments to the States remain the same. 20 MR. BARFIELD: I move adoption of the fiscal 21 year 2009/2010 first revision and the proposed 2010/2011 22 proposed budget. 23 VICE-CHAIRMAN: Second? 24 MR. HEIMERLICH: Second. 25 MR. MILLER: Contract ratification? 26 MS. GIMBEL: We got to vote on it actually.

1	MR. MILLER: Oh, I'm sorry.
2	VICE-CHAIRMAN: Colorado votes?
3	MR. HEIMERICH: Colorado votes aye.
4	VICE-CHAIRMAN: Kansas votes?
5	MR. BARFIELD: Kansas votes aye.
6	VICE-CHAIRMAN: Motion carried.
7	MR. MILLER: Incorporated into those budgets
8	you just took are two contracts that you should have
9	ratified before the budget, but we talked about it. So
10	there is the added agenda items. The approval of the
11	amended State of Colorado satellite monitoring contract
12	for the period of July 2008 through June 2011 at an
13	annual price of \$12,400. And that's an amendment of the
14	contract you approved last year and it included 11
15	stations. We are now going to be monitoring 12 stations.
16	VICE-CHAIRMAN: We discussed that last night.
17	MR. MILLER: The signatory on that would be
18	Stephanie, so what we would be asking is for you to
19	ratify or approve Stephanie entering into that contract
20	on behalf of ARCA with Dick Wolfe.
21	MR. HEIMERICH: So moved.
22	MR. BARFIELD: Seconded.
23	VICE-CHAIRMAN: Moved second. Any other
24	discussion? If not, Kansas vote?
25	MR. BARFIELD: Aye.
26	VICE-CHAIRMAN: Colorado?

1 MR. HEIMERICH: Aye. 2 VICE-CHAIRMAN: Motion carried. 3 MR. MILLER: And then there are two contracts 4 with the United States Geologic Survey (USGS) for the 5 gage program assistance they provide: One with the State 6 of Colorado section; one with the Kansas section. And in 7 both cases you would again be authorizing Stephanie to 8 sign those contracts for calendar year 2009. If you 9 would like the record to show the price of those, I can 10 tell you -11 VICE-CHAIRMAN: If you have them. 12 MR. MILLER: Actually, the contract with the 13 Colorado section will be -- ARCA's share of that cost 14 would be \$46,360. And with the Kansas section, this one 15 just got handed to me last night. 16 MR. MILLER: Is Craig Dare still there behind 17 me? 18 UNKNOWN SPEAKER: No, he left. 19 MR. MILLER: 8,300 for calendar year 2009. 20 That was Recording Secretary Gonzales who confirmed the 21 number. 22 VICE-CHAIRMAN: That's the joint contract or 23 joint --24 MR. MILLER: Joint Funding Agreement. 25 VICE-CHAIRMAN: Any motion to --

1 MR. HEIMERICH: So we want to move that 2 Stephanie has authority to sign on the Joint Funding 3 Agreement? MR. MILLER: Kansas section of USGS and 4 5 Colorado section of USGS. MR. HEIMERICH: So moved. 6 7 VICE-CHAIRMAN: Second? 8 MR. BRENN: Second. 9 VICE-CHAIRMAN: Any more discussion? If not, 10 Kansas vote? 11 MR. BARFIELD: Aye. 12 VICE-CHAIRMAN: Colorado? 13 MR. HEIMERICH: Colorado votes aye. 14 VICE-CHAIRMAN: Motion carried. That takes 15 care of the budget items, Steve? 16 MR. MILLER: It does. And I don't know if you 17 were going to talk about minutes or not next? 18 VICE-CHAIRMAN: I'm trying to debate if there's any action to be taken on those. 19 MS. GIMBEL: I don't think so. I don't think 20 21 there's any action. 22 MR. MILLER: There's nothing new to be 23 approved. There's been a transfer of drafts, exchange of 24 drafts with Kansas, and we'll try to keep the 25 Administrative and Legal Committee informed as we make 26 progress on that. We did make some progress last year.

1 VICE-CHAIRMAN: Good. And the same with the 2 annual reports; they think they are just updated as to the process of getting those completed. 3 4 MR. MILLER: We have started -- Colorado has 5 generally prepared the first draft, and we started that. Both starting at the year 2000 and starting at the year 6 1994 where we stopped prior. And we'll have to work out 7 8 a review process with the State of Kansas. When we 9 stopped doing those, the spreadsheets were not a common 10 tool, at least not in our circle. So hopefully the 11 review process will be easier for both States. But I 12 think we talked just a minute ago maybe using the 13 Operations Committee is a way of getting drafts in front 14 of ARCA and getting some initial comments, and I think 15 it's basically going to come down to Kevin and I. But if 16 we work through the Operations Committee, we could do it 17 with engineering as well. I don't know. It's up to the 18 Administration. 19 MR. BARFIELD: We were actually having a side 20 discussion here and wondered if Administrative and Legal 21 would be the appropriate body to be doing the reports. 22 We just want to spread the fun as part of it. 23 MR. MILLER: When I was given this job back in 24 '91, my boss told me don't ever start a report until the 25 previous one is completed because there was a risk. We were using secretaries basically to do the work. 26

1 didn't know. And they had no reason to. To get this 2 backlog done, we are talking about maybe generating two 3 or three at a time or -- and maybe '95 and 2001 are both being -- and it's a technical review. I don't know that 5 -- I know Jennifer is not going to do it. She's going to tell me to do it in a hurry. You don't really have staff 7 to do it. It needs someone that can run some numbers; and so whichever committee it goes to I think is going to 9 delegate it to employed State staff from both States. 10 MR. BARFIELD: The appropriate people will 11 review the reports, no matter which committee we assign 12 this to. It just seems like it's really in the purview 13 of the Administrative Legal Committee. 14 MR. MILLER: So Randy can give work 15 assignments to Kevin. I know, Jennifer, you give me -16 plenty. 17 VICE-CHAIRMAN: Definitely. 18 MR. MILLER: All I need is a process and then 19 at least some decisions about what ought to be in the 20 report as we move forward with the '97 resolutions or 21 Offset Account. We have never addressed that in the 22 annual report. 23 VICE-CHAIRMAN: Kevin, do you have questions? 24 MR. SALTER: I think Steve mentioned earlier,

there's probably going to be some coordination between

two or maybe all three committees as far as the ARCA

25

- 1 annual reports because of the changes that have occurred
- in the last 15 years since we put out an annual report.
- 3 So Steve has suggested that maybe the operations take a
- 4 look at some of the new tables and stuff that deal with
- 5 operations that go with the annual reports. I think
- 6 maybe assign to administrative and legal, recognizing
- 7 that maybe coordination with operations and engineering
- 8 as appropriate.
- 9 MR. MILLER: I hope there can be one committee
- that's lead. If it goes to all three committees, it
- 11 might as well not go to any. I might as well send it to
- everyone in the front of the room. I'm open to anything,
- and I've got a lot of work to do. It doesn't affect what
- 14 I'm going to do over the next three or four months. We
- 15 need to be thinking about it and have some way of getting
- those out and approved to distribute. That's the other
- thing on the annual report. We are not doing photoset
- printing anymore. It's going to be on the Internet.
- 19 There's going to be a limited hard copy and the rest will
- 20 be CDs. So we can go from approval to distribution
- 21 fairly quickly.
- MR. SALTER: Mr. Chair, can I have a couple
- 23 minutes? If I remember right, the 2005 resolution for
- 24 Special Engineering Committee has items dealing with ARCA
- 25 annual reports.

1 MR. BARFIELD: That's true. If I had a 2 moment, I can confirm that. MR. MILLER: Would that be the 2006 annual 3 report or just the 2005? I don't know if you want to 4 5 take more time on it now. VICE-CHAIRMAN: Did you have conversations? 7 MR. HEIMERICH: Well, I guess my question is, 8 one of the things then from our Operations Committee 9 standpoint is where to put the ten-year accounting. 10 That's -- do you have in the report what kind of 11 introductory and how it's going to be characterized so that both States understand fully and completely how they 12 13 are approving it and what they are approving and how the 14 U.S. government will interpret it? The other issue is 15 how to try to get through this backlog of things that now 16 no one actually remembers because now we are talking 17 again technology changing faces. So I don't know. I'm 18 just kind of wondering. But to tell you the truth, I am 19 a little concerned because when we go through and look at 20 all that ARCA does, there's one name that keeps coming up almost as much as Mr. Witte's name and that's Mr. Salter. 21 22 And I'm really wondering if Mr. Salter ever sleeps or if 23 he has any kind of personal life at all. And although 24 that's humorous, the point is I'm wondering if, in fact, by having Kevin look at parcel numbers and acreage under 25

the Trinidad project, looking at the accounting issues

- 1 and trying to deal with the Offset Accounting and now
- 2 really wondering if there isn't another in Kansas in its
- 3 hope to try to get through the backlog, because I'm
- 4 assuming once the backlog is completed, things would
- 5 hopefully go better. So I'm really wondering if we are
- 6 not stretching Mr. Salter too thin in having him and
- 7 he's always under pressure to meet these deadlines. I'm
- 8 wondering if there's another way to -- Kevin, is there
- 9 anyone else in your staff or is staffing available that
- 10 can be assigned so that you're not completely (Mr. Salter
- 11 points to Brandy Cole and Chelsea Juricek). Okay. I'm
- just sensitive to your time, Kevin, because I know we
- have these issues, and I'm always asking why -- how come
- this is not responded to. I think --
- MR. MILLER: When I first started working on
- this, there was a young kid in Topeka named David who I
- 17 used to work with on that. Maybe someone at Topeka, I
- 18 don't know.
- MR. HEIMERICH: Thank God for Topeka.
- MR. BARFIELD: Actually Burke is here. He's
- 21 the new Lee Rolfs obviously. So we'll be involved in
- some of that work from a legal perspective. Lee
- obviously has done quite a lot of our work in terms of
- reviewing the reports and the transcripts. And Chris
- 25 here is also -- Topeka is also going to help us get this
- done.

1	MR. HEIMERICH: Well, my suggestion would be
2	to split it into two tasks. I think finding out where
3	and how the ten-year accounting and reporting is done.
4	Just one specific task because irregardless of where or
5	how we come up with a mechanism and how it's introduced
6	into the report is a stand alone issue. The other issue
7	is obviously getting through and grinding through the
8	annual reports and having some way of verifying so that
9	both States at this level feel comfortable when the staff
10	recommends or a recommendation comes through one of the
11	committees that we should adopt it. So perhaps what we
12	could do is assign the ten-year accounting to go through
13	the Operations Committee because that does seem to be
14	somewhat technical in nature, and it's already been
15	brought before that committee which makes, I think,
16	reasonable sense. Is this okay with Colorado? The other
17	issue there is it seems like some reasonable nexus
18	between the annual reporting and what the legal and the
19	administrative committee does. So perhaps those past
20	annual reports could be vetted through the Administrative
21	and Legal Committee for their recommendation to the full
22	ARCA that they be adopted. Because I think that's kind
23	of how we work.
24	I mean, Administrative and Legal consider the
25	adoption of x, y, z accounts. Then they would look at
26	it. It would come before ARCA as a resolution, as a

- 1 recommendation, or an X report, and we would take action
- and either simultaneously, or I suppose it could happen
- 3 even after the fact, that ten-year accounting issue could
- be inserted. I mean, we are going to have to go back in
- 5 time anyway.
- 6 MR. MILLER: The only thing I would say on
- 7 that, Matt, is with the annual reports, and you probably
- 8 have never seen one because there's never been one in
- 9 your tenure.
- 10 MR. HEIMERICH: I would like to see one.
- 11 MR. MILLER: It's 90 percent hydrologic and
- 12 reservoir accounting.
- MR. HEIMERICH: Which is a big document that
- 14 Steve would always bring forward.
- MR. MILLER: That is about 14 tables and 14
- 16 appendices showing stream flows and delivery rates and
- 17 reservoir contents. And it wasn't just a financial
- 18 statement. We would have done them we have never had a
- 19 problem agreeing on that part of it, only the hydrologic
- 20 information. But I'm fine with sending it to Randy as a
- 21 draft. I don't expect you to get a spreadsheet and start
- 22 cranking numbers then you'll find out who in Kansas can
- do that for you.
- 24 MR. HEIMERICH: We'll leave it at that.
- That's fine. When it goes to you, Jennifer, that won't

- 1 be an issue because you're going to be supervising the
- 2 preparation.
- MS. GIMBEL: We'll see.
- 4 MR. HEIMERICH: I'm just doing this off the
- 5 cuff. I'm just trying to figure out how we can move
- forward so that the annual reports can be affected and
- 7 completed so we can get back on a time table and live up
- 8 to the obligations of what we said we would do. I think
- 9 Special Master wants to see it happen. I think probably
- 10 the United States government wants to see it happen. I
- 11 would like to see one before I leave.
- 12 VICE-CHAIRMAN: Realistically, how many annual
- 13 reports backlogged can you do in a year's time?
- MR. MILLER: I think we can do all the way
- 15 through two -- I have the data through 2004 and that was
- not a hard process. I'm missing one set from Kansas, and
- I know they are working on it. I have already talked to
- 18 Kevin. To pull 2004 through -- 2008, I don't know,
- because I have never tried to do a year that had just
- 20 closed. So some of the web sources like USGS, when that
- 21 becomes final, when our own diversion records from
- 22 Colorado get into the database, I don't know how quickly
- 23 that occurs, but through 2007 can certainly be done by
- next year on a schedule three or four every two or three
- months.
- VICE-CHAIRMAN: Through 2006?

1 MR. MILLER: Through 2007. 2 MR. HEIMERICH: With that being said, I think 3 this Colorado commissioner would see that that is a 4 fairly high priority. If we keep getting backlogged, we 5 are never going to get it done. And then it's always 6 hanging out there over everyone's head, kind of 7 shadowing. We can't move on with some other issues 8 because we are dealing with limited manpower issues as 9 well. 10 MR. MILLER: They are pretty much cookie 11 cutter until you change how John Martin functions. So 12 the Offset Account will require some new text, and then 13 we'll have to hash out that. If the attorneys might want 14 to get involved and this is how we describe well I got 15 accounts there. How we introduce the subject that 16 there's a new table. Then you go along until there's 17 another change, and that might be the decree being 18 finalized. And that's the point where we introduce some 19 more information. And again, you can get three or four. 20 And if you look at one and say what was the end of the 21 year contents? You look at the next years. You say 22 what's the -- they start at the right number, and you 23 just approve two or three as a slug. 24 VICE-CHAIRMAN: Kevin? 25 MR. SALTER: Kind of bring you back to the 26 point I think is who do you assign the annual report

- drafting to? Thanks to Sam Speed, we have got Article 5,
- 2 the Bylaws that describes the committees. "The standing
- 3 committees shall have the following duties under
- 4 Administrative and Legal Committee: It shall advise the
- 5 Administration with respect to the several different
- 6 tasks and shall prepare the draft of the annual report of
- 7 the Administration." So it seems like the bylaws
- 8 squarely puts it in the Administration and Legal. I did
- 9 mention earlier that the Resolution 2005 for the Special
- 10 Engineering Committee did have a task. That was task C,
- 11 to provide guidance to the Administrative and Legal
- 12 Committee and his designee on preparing drafts of the
- annual reports to the Administration. And then goes on.
- 14 So I think those two have been identified previously by
- 15 the Administration.
- 16 VICE-CHAIRMAN: Okay. I think that sounds
- 17 like the appropriate way to approach that then. I will,
- I guess, at least see if we can attempt to get these
- 19 reports going again.
- MR. MILLER: I'll send it to you.
- 21 VICE-CHAIRMAN: Jennifer's chair.
- MR. SALTER: In summary, I guess I agree with
- your earlier statement, I guess, about ten-year
- 24 accounting being assigned to the Operations Committee,
- for them to come up with a recommendation about how to do
- 26 that.

1 MR. HEIMERICH: Okay. 2 MR. MILLER: But the annual report preparations is in the purview of the Administrative and 3 Legal, and they can reach out and get help wherever they 5 need it. And, as Kevin mentioned, the Special 6 Engineering Committee is tasked by ARCA to provide any 7 assistance that Committee needs to complete the task. VICE-CHAIRMAN: All right. I think we 8 9 resolved that, I hope. MR. HEIMERICH: I think we have. 10 11 VICE-CHAIRMAN: 14.B, I think is the last item 12 under 14. That's the resolution for the continuation of the Special Engineering Committee. Who has that? David? 13 14 MR. BARFIELD: Yes. Let me just read the 15 resolution. I think we have had plenty of discussion on 16 the background. This would be Resolution 2008-4 17 regarding third extension of the term of the Special 18 Engineering Committee. 19 "Whereas, pursuant to Bylaw Article 5, the Arkansas 20 River Compact Administration by resolution created the 21 Special Engineering Committee --22 COURT REPORTER: Slower, please. 23 MR. BARFIELD: Actually, I'm just going to 24 read the resolved. It basically says we created this Committee in 2005. We extended it to 2006 and 2007; 25

1 "Whereas, at the 2008 Annual Meeting, the Special 2 Engineering Committee has again reported the 3 Administration on its successful resolution of several 4 additional disputed issues and the potential for further 5 agreement. 6 "Now, therefore, be it resolved that the Arkansas 7 River Compact Administration does hereby extend the term 8 of the Special Engineering Committee one full year to 9 expire on December 31, 2009. All other Special 10 Provisions of the 2005 Resolution shall remain unchanged 11 and govern the actions of the Special Engineering 12 Committee during this third extension throughout 2009." 13 Adopted today by the Administration. 14 I would move we adopt this resolution. 15 VICE-CHAIRMAN: Second? 16 MR. HEIMERICH: Second. 17 VICE-CHAIRMAN: Any discussion? My notes said 18 that was the third extension of the Special Engineering 19 Committee. 20 MR. BARFIELD: That's right. 21 VICE-CHAIRMAN: No discussion. Colorado vote? 22 MR. HEIMERICH: Colorado votes aye. 23 VICE-CHAIRMAN: Kansas? 24 MR. BARFIELD: Kansas votes aye. 25 VICE-CHAIRMAN: Motion carried. Special 26 Engineering Committee is extended for another year. Item

- 1 15 is future meetings. Do we have some slated for the 2 Operations Committee or tentatively?
- MR. BARFIELD: We have slated a potential
- 4 based on need in April or mid-summer.
- 5 VICE-CHAIRMAN: Now it sounds like you might
- 6 have to have maybe a special Administrative and Legal
- 7 Committee.
- MS. GIMBEL: At least one, maybe two.
- 9 VICE-CHAIRMAN: Special meetings of the
- 10 Administration? I don't foresee anything for the full
- 11 Administration to meet at this time. And the date for
- 12 the 2009 annual meeting is -- I haven't looked that far
- 13 ahead -- but it's slated.
- MR. HEIMERICH: Steve, what are the dates for
- 15 '09?
- MR. MILLER: I don't have a calendar. It's
- 17 always the second Tuesday of December.
- MS. GIMBEL: December 8th.
- 19 VICE-CHAIRMAN: Very good. Any other
- 20 business?
- 21 MR. BARFIELD: With respect to the annual
- 22 meeting, I certainly appreciate the State of Colorado and
- 23 others here. They are hosting this meeting annually. I
- 24 quess I would like to once again on behalf of Kansas
- 25 extend an offer for State of Kansas hosting this meeting
- in Garden City next year. This invitation obviously has

1 been extended before. We understand that, you know, 2 there's an additional effort that we are required of 3 Coloradoans to come to Kansas, but we appreciate the 4 opportunity to host it on a relatively infrequent basis 5 just to increase the participation and knowledge of Kansas on the important work of ARCA. And I think it's 6 7 an opportunity for Coloradoans to sort of learn a little 8 bit about Kansas as you venture on that side of the 9 Stateline, and so I guess I would offer on behalf of our 10 delegation here to host the meeting in Garden City. 11 MR. THOMPSON: I have talked to some guys and 12 most of the guys down in here have maybe agreed that it 13 would be okay on a temporary basis to maybe have it next 14 year in Garden City. Acknowledging that this is still 15 the home stomping grounds of the Compact and more 16 centrally located over time so that the Colorado quys 17 don't have to go as far. And I think there are surely 18 some ribeyes or something that come with it. 19 VICE-CHAIRMAN: I don't think it sets any 20 precedents, but it's been several years since we have had 21 the annual meeting there. I don't recall what the last 22 The only one that I recall was probably ten year was. 23 years ago. Anyway, I assume so. I would appreciate 24 that. I would be glad to have you come to Kansas for the

annual meeting. We look forward to that.

1 MR. HEIMERICH: Could we have Mr. Miller maybe 2 just speak to them on logistics? Steve, I am assuming --3 is it you or Stephanie that makes the arrangements for 4 all the meeting halls and making sure that there is 5 places for reservations and getting the word out? I 6 mean, so that if, in fact, we do agree that Garden City 7 is the appropriate host for the '09, how does Kansas go 8 about, I mean, doing that? 9 MR. MILLER: I'm sure Stephanie will provide 10 assistance. Colorado took the lead here, but since it's 11 a repetitive process, Stephanie knows what to do or who 12 to contact better than I do. She makes the arrangements 13 for this meeting. If provided with the information on 14 who we want to deal with in Kansas, she can do that. The 15 biggest issue for you guys is the out-of-state travel. 16 So Jennifer has to approve the travel. This is really 17 the only issue I see. 18 MS. GIMBEL: So does the Governor. 19 MR. BARFIELD: I believe we need to take a 20 formal action according to the bylaws, correct? 21 bylaws do provide for this. So I guess I would make a 2.2. formal motion that we have the annual meeting of ARCA at 23 Garden City, Kansas next year. 24 VICE-CHAIRMAN: Is there a second?

MS. GIMBEL: We'll second that.

1 VICE-CHAIRMAN: Moved and seconded. Do we 2 have the annual meetings in Garden City next? Any more discussion? Hearing none, Colorado vote? 3 4 MR. HEIMERICH: Colorado votes aye. 5 VICE-CHAIRMAN: Kansas vote? 6 MR. BARFIELD: Kansas votes aye. 7 MR. MILLER: David or Randy, maybe David, one 8 of you decide who is going to coordinate with Stephanie 9 on location and just so we get the agenda and titles and 10 stuff like that. 11 VICE-CHAIRMAN: She corresponds with me as 12 Vice-Chair anyway. So I would be glad to help coordinate 13 that. 14 MR. MILLER: I appreciate that very much. 15 VICE-CHAIRMAN: Look forward to seeing you 16 there. I don't have anything else. Is there any other 17 business for the Administration, Steve? 18 MR. WITTE: How will the handling of the 19 distribution of the action items and the resolutions be 20 done? 21 VICE-CHAIRMAN: I'm assuming as soon as we 22 adjourn we'll get all of those signed and instructions to 23 the reporter. We'll want you to distribute your notes as 24 rapidly as possible to both States so that they can get 25 started working on those. Is that what your question 26 was?

1 MR. MILLER: In particular, the resolutions 2 passed today and the action items in committees yesterday 3 need to be distributed to staff so we can have a record 4 of what our expectations and assignments are for the 5 coming year. As long as we are still on the record, 6 anybody who introduced anything to sign needs to make 7 sure four originals are up front within the next 15 8 minutes. We are going to sign four sets of originals and 9 distribution would be one to the reporter, one to 10 Stephanie, one to me with the responsibility of getting 11 it to anybody in Colorado. And I can take care of some 12 of that right here on the spot in the front office here. 13 And one to Kansas, whoever that ought to be. But four 14 original signatures in the next five minutes up front. 15 MR. BARFIELD: Well, that does now address 16 your concern, Steve, right? 17 MR. WITTE: Right. 18 MR. ### Report of U.S. Geological Survey Water-Resources Activities in the Arkansas River Basin of Colorado to the Arkansas River Compact Administration

### December 9, 2008

In 2008, 10 streamflow gages were operated under the USGS/ARCA cooperative program; eight in Colorado and two in Kansas. Final annual flows for WY2008 are shown in the following table.

No significant problems were encountered in the network with the exception of continuing beaver dam problems at the Big Sandy near Lamar gage. The Colorado Department of Transportation (CDOT) is now involved in the removal of beaver dams at Highway 196 just below the gage and has recently involved a trapper to remove beavers from the area. It is proposed that we operate the Big Sandy gage and monitor the situation throughout the remainder of 2009.

In 2009, the USGS proposes to continue operation of the 10 streamflow gages.



Report of Civil Works Activities for 2008

- 1. <u>General</u> During 2008, activities of the U.S. Army Corps of Engineers, Albuquerque District (Corps) in the Arkansas River Basin consisted of reservoir regulation, flood-control related studies, flood plain management services, regulation under Section 404 of the Clean Water Act, and emergency assistance.
- 2. <u>Flood Control Operations</u> The Arkansas River Basin snowmelt runoff was above normal throughout the upper basin, and slightly below normal in the southern sub-basins.

The upper Arkansas basin in terms of snow pack, reached a well above normal high of 147% of average. The southern sub-basins were also well above normal at 173% of average.

There were no Corps flood-control operations at Trinidad, John Martin, or Pueblo.

Sediment Deposits - At John Martin, an accumulation of sediment on the dam's upstream face is hindering scheduled maintenance and inspection of the emergency sluicing gates. In order to alleviate this problem, the Corps has issued a 3.1 million dollar contract to hydraulically dredge and remove approximately 90,000 cubic yards of sediment material. The dredged material is being deposited in a retention pond approximately 1.5 miles from the dredging site where it will be used in the future construction of endangered species habitat islands.

The operation is ongoing and is on scheduled to be completed by February, 2009. Hydraulic dredging is the best method for removing these sediments. We are confident the operation will have the least impact on turbidity, and not result in "Action Level" increased concentrations of organics or metals. The Corps will implement, and maintain, Best Management Practices during construction in accordance with our Construction Stormwater Permit.

Stilling Basin Inspection - The Corps has conducted a small scale core sampling operation on sediment deposits within the stilling basin below the reservoir. The sediment will be removed once the stilling basin has been drained in order to conduct a proper inspection of the entire concrete apron and stilling basin works. The stilling basin sediment removal and inspection is scheduled to take place during the winter months of FY09.

### Trinidad Lake

Embankment repair - A project to repair portions of the embankment immediately downstream of the outlet works below Trinidad Dam is currently underway. The embankments were damaged during releases in August of 2004. A tiered Gabion basket system will line both sides of the channel for approximately 170' below the outlet works. The project is expected to be completed in December, 2008.

Trinidad Downstream Capacity Study - The Corps, along with the United States Bureau of Reclamation (USBR) and other state and local agencies pursued efforts to combine resources in FY08 to conduct a study to definitively determine the existing hydraulic capacity of the Purgatoire River below Trinidad Lake. To date, mapping data has been collected and the hydrologic modeling effort is underway. Model results will be available in February, 2009.

3. <u>Planning Assistance to States (Section 22) Program</u> Under authority of Section 22 of the Water Resources Development Act of 1974 (WRDA), the Corps is authorized to assist Non-federal entities in the preparation of comprehensive plans for the development, use, and conservation of water and related land resources.

There are no new or ongoing studies in the Arkansas Basin under the Planning Assistance to States Program.

- **4.** Continuing Authorities Program There are three active Continuing Authorities Program projects in the Arkansas River basin.
- a. <u>Section 205</u> Under Section 205 of the 1948 Flood Control Act, as amended, the Corps is authorized to plan and construct small flood damage reduction projects that were not authorized by Congress.

A Section 205 feasibility study at Florence along the Oak Creek, a tributary to the Arkansas River, is in the feasibility stage. The project was being designed to fulfill both flood control and water supply objectives. However, the water supply component was determined infeasible due to high costs for dam construction. During FY08 the study was placed on hold while sponsor evaluated funding sources and decided whether to continue with the sole objective of flood control. The study will resume in FY09.

b. <u>Section 206</u> The 1996 Water Resource Development Act provided authority for aquatic ecosystem restoration projects in areas unrelated to existing Corps water projects.

There is currently one active Section 206 project in the Arkansas River Basin, the Arkansas River Fisheries Habitat Restoration project. The Project Cooperation Agreement was signed with the City of Pueblo in April of 2002. The project will improve fish and riparian habitat along ten miles of the Arkansas River downstream of Pueblo Dam.

The majority of construction work has been completed, including J-hooks, weirs, a fish ladder, vegetated bars, boulder clusters, exotic vegetation removal and replantings. The project is scheduled for completion in FY09.

c. <u>Section 14</u> Under Section 14 of the 1946 Flood Control Act, as amended, the Corps provides emergency streambank protection works to prevent damage to public facilities.

Currently, there are no active Section 14 projects in the Arkansas River Basin.

d. <u>Section 1135</u> The 1986 Water Resources Development Act authorized the review of completed water resources projects to implement modifications that improve the quality of the environment, when environmental degradation resulted from the Corps project.

Currently, there are no active Section 1135 projects in the Arkansas River basin.

One potential Section 1135 feasibility study would determine Federal interest in removing exotic vegetation and replanting with native vegetation at John Martin Reservoir. The sponsors are Colorado State Parks and Colorado Division of Wildlife. The project is currently unfunded.

5. <u>General Investigations</u> The Corps' General Investigations program provides for large comprehensive solutions to complex problems that can explore solutions on a watershed scale.

A study is currently underway at Fountain Creek, which began in 2002 and will be completed in December, 2008. The study will identify a suite of projects to address issues on the Fountain in the areas of flood damage reduction, ecosystem restoration, and channel stability. The study will be limited to identifying implementation strategies/project delivery mechanisms for each

potential project, and will establish baseline conditions for the environment, hydrology, and hydraulics of the watershed.

6. Flood Plain Management Services The Corps Flood Plain Management Services (FPMS) Program authority stems from Section 206 of the Flood Control Act of 1960 (PL 86-645), as amended. The objective of the Flood Plain Management Services Program is to support comprehensive floodplain management with technical services and planning guidance at all appropriate governmental and community levels. These services are provided to State, regional, and local governments and Indian tribes at no cost. Section 321 of the Water Resources Development Act of 1990 requires recovering the cost of services provided to federal agencies and to private entities. A fee schedule has been established.

Section 202 of the Water Resources Development Act of 1999 (PL 106-53) authorizes the Secretary of the Army to collect funds contributed voluntarily from State, regional, and local governments, Indian tribes, and other Non-federal public agencies for the purpose of recovering the cost of providing services pursuant to Section 206.

Services available include assistance relating to the interpretation and evaluation of basic flood-hazard data, guidance in preparation of floodplain regulations, advice on the use of data regarding possible alternative developments in flood-prone areas, guidance on structural and nonstructural measures that might be employed to reduce flood hazard, and in some cases, development of basic flood-hazard data.

Under authority of an *Interagency Agreement* with the Federal Emergency Management Agency Region VIII, the Corps initiated in 2004 a Flood Insurance Study for a portion of Black Squirrel Creek and 5 tributaries in El Paso County, Colorado. The digital topographic mapping for the study area, developed by the El Paso County Department of Transportation and funded by the Corps. The study was submitted to the Federal Emergency Management Agency (FEMA) for review, and comments are currently being addressed.

In addition to this study, the Corps received approximately ten requests for technical services at specific sites within the Arkansas River Basin.

7. <u>404 Permits</u> Section 404 of the Clean Water Act prohibits discharges of dredged or fill materials into waters of the United States, including wetlands, without a permit from the Corps.

In 2008, 6 individual permits were issued in the Arkansas River Basin. An additional 274 activities in the basin were reviewed during the period and most were covered under nationwide permits.

### 8. Emergency Management Coordination

Public Law 84-99 gives the Corps of Engineers the authority to assist state and local governments before, during and after flood events. The Corps' Emergency Management Branch works with Local governments to inspect numerous flood control projects throughout the Arkansas River Basin to ensure that these facilities are in proper operational condition for the next flood season.


During years with high snow pack, the Corps works with the Colorado Water Conservation Board to prepare for flood fight activities that may be required.

During the past year, the Emergency Management Branch received no contacts from local governments and private citizens in the Arkansas River Basin requesting information or assistance regarding flood related activities.

Under the Rehabilitation and Inspection Program, the Corps prepared a Project Information Report (PIR), to determine if the Corps could rehabilitate the damage caused by a flash flood to the Pueblo Fountain Creek Floodway Project. Once the PIR was approved, a contract was awarded and work to rehabilitate the project was completed in the fall of 2008.

### NOTES TO FINANCIAL STATEMENTS June 30, 2008

### NOTE 1 Organization:

The Arkansas River Compact was formed in 1948 to settle existing disputes and remove causes of future controversy between Colorado and Kansas concerning the waters of the Arkansas River and their control, conservation and utilization for irrigation and other beneficial purposes.

### NOTE 2 Summary of significant accounting policies:

- a. The Arkansas River Compact Administration (the Compact) maintains financial records using the cash basis of accounting. By using the cash basis of accounting, certain revenues are recognized when received rather than when earned, and certain expenses and purchases of assets are recognized when cash is disbursed rather than when the obligation is incurred.
- b. The Statement of Receipts and Disbursements is shown only to reconcile the beginning and ending cash balances. It is not intended to reflect income and expense recognition. Income and expenses are reflected in the Statement of Revenues and Expenses with Budget Comparison.

### NOTE 3 Special Projects and Studies:

This represents the completion of a transit loss investigation study prepared by Livingston Professional Services – Hydrologic Sciences. The following summary reflects the payments made toward this project with the corresponding amount budgeted:

WHEREAS, tamarisk is a phreatophyte species that is impacting the limited water resources in the over-appropriated Arkansas River basin; and

WHEREAS, this tamarisk infestation is not limited to just one watershed or just one State and any tamarisk control project should not be limited by State boundaries.

**NOW, THEREFORE BE IT RESOLVED** that the Arkansas River Compact Administration supports the States of Colorado and Kansas in pursuing funding through Public Law 109-320, *The Salt Cedar and Russian Olive Demonstration Ac,t* and other Federal funding to fund a joint tamarisk control and watershed restoration project in the Arkansas River basin.

NOW, THEREFORE, BE IT RESOLVED that the Administration hereby adopts the recommendations in the attached Recommendation G of the Special Engineering Committee, EXCEPT that all references to Reports of the Colorado State Engineer Concerning Accounting of Operations of an Offset Account in John Martin Reservoir for Colorado Pumping (Offset Account Reports) are excluded from approval by this Resolution, and EXCEPT that the proviso to be added to the cover page of each Annual Report of the Operations Secretary referred to in paragraph A.3 of Recommendation G shall be modified to read as follows:

The Annual Reports of the Operations Secretary for Compact Years 1994 through 2005 have been approved by the Arkansas River Compact Administration with the following proviso:

The values and operations in this report have been in dispute. An addendum report, dated December 9, 2008, contains the revised values that have been determined through agreement by the States. However, while Kansas and Colorado have agreed that accounting prior to 2006 will not be otherwise revised, Kansas does not waive any claim for past damages or restitution of water on the unresolved, disputed issues of upstream storage during spills and Agreement B.

## Recommendation G Special Engineering Committee May 1, 2008

Recommendations for Revision and Approval of Annual Reports of the Operations Secretary for Compact Years 1994-2006, Restitution for Transit Losses on Releases of Water from the Kansas Section II Account That Were Not Replenished From the Kansas Transit Loss Account, and Other Assigned Tasks

The Arkansas River Compact Administration (ARCA) created a Special Engineering Committee ("Committee") by Resolution No. 2005-1 and directed the Committee to develop recommendations to ARCA to reduce or eliminate disputes between the States. ARCA extended the term of the Committee by Resolution Nos. 2006-7 and 2007-4.

Pursuant to these Resolutions, Jennifer Gimbel and Dick Wolfe, for Colorado, and David Brenn and David Barfield, for Kansas, were designated as members of the Committee, and Robin Jennison, the Federal representative and Chairman of ARCA, was made an *ex-officio* member of the Committee.

The Committee was assigned the tasks of developing recommendations to resolve various long standing disputes as described in ARCA Resolution 2005-1, including "The review and recommendation on the revision and approval of all Annual Reports of the Operations Secretary for Compact Years 1994-2004, to include the status of the Report for Compact Year 2005 if not approved by ARCA at the December 2005 Annual Meeting." During the Committee's deliberations, the effects of the implementation of new accounting procedures on accounting during prior years, and how any restitution of water would be made were considered. The Committee makes the following recommendations to ARCA, with the condition that <u>all</u> of the following recommendations will be adopted, or <u>none</u> of them will be adopted:

- A. The Committee recommends that the Annual Reports of the Operations Secretary submitted for Compact Years 1994 through 2006 be approved<sup>2</sup> except as provided below and with the following qualifications:
  - 1. The values for Kansas Section II Account water deliveries measured at the Stateline ("Stateline deliveries") will be revised *via* an addendum to the 1994 through 2005 reports. This addendum will report the Stateline deliveries using the criteria provided in the Agreement Concerning the Offset Account in John Martin Reservoir for Colorado Pumping, Determination of Credits for Delivery of Water Released for Colorado Pumping, and Related Matters approved September 30, 2005 ("2005 Offset Account Crediting Agreement") and the 2006 Agreement on Measurement of Section II Deliveries.

- 2. The values of Offset Account water released and measured at the Stateline should be revised *via* an addendum to the 1997 through 2005 Reports of the Colorado State Engineer, Concerning Accounting of the Operations of an Offset Account in John Martin Reservoir for Colorado Pumping (Offset Report). This addendum will report the values for the deliveries using the criteria provided in the 2005 Offset Account Crediting Agreement.
- 3. An addendum proviso should be added to the cover page of each Annual Report of the Operations Secretary for 1994 through 2005 and each Offset Report for the years 1997 through 2005 stating as follows: "The Annual Report of the Operations Secretary for Compact Year \_\_\_ [or the Offset Account Operations Report for \_\_\_ (year)] has been approved by the Arkansas River Compact Administration with the following proviso: The values and operations in this report have been in dispute. An addendum report, dated \_\_\_\_, contains the revised values that have been determined through agreement by the States. However, while Kansas and Colorado have agreed that accounting prior to 2006 will not be otherwise revised, Kansas does not waive any claim for past damages or restitution of water on the unresolved, disputed issues of upstream storage during spills and Agreement B."
- 4. Deliveries of water to John Martin Reservoir under Section III of the 1980 Operating Plan, and particularly the method for determining the Winter Water split<sup>3</sup> contained in the Annual Reports of the Operation Secretary for 1994 through 2006, will not be revised or recalculated. However, this shall not set any precedent as to how this accounting should be done if this Recommendation is adopted by ARCA. This recommendation is not intended to preclude either State from proposing a revision of the method for calculating deliveries of water to John Martin Reservoir under Section III in the future or the States continuing to work towards agreement on the method.
- B. The Committee recommends that no restitution be made for water lost to evaporation during John Martin spill events<sup>4</sup> prior to 2006.
- C. While some transit losses on releases of water from the Kansas Section II account were replenished from the Kansas transit loss account in accordance with Section II E 4 of the 1980 Operating Plan; the Committee has determined that some transit losses were not replenished from 1996 to 2006 (past deficits). In this document the term, "past deficits" refers only to the deficits accumulated during Compact Years 1996 through 2006. The Committee recommends that restitution for the past deficits be made as provided for in this recommendation. The Committee has quantified the amount of the past deficits as 3,633 acre-feet. For only these past deficits, Colorado will deliver 3,062 acre-feet (2,491 acre-feet plus half of what would normally have been derived from Kansas' portion of the 35% distribution) to the Kansas Section II account by no later than May 15, 2008. The water to be delivered has been derived from Arkansas River Basin consumable sources as described in the attached letter agreement from either Lake Meredith or Pueblo

Reservoir. Colorado agrees to use the Livingston transit loss method to compute the delivery transit loss, both consumed and unconsumed, to deliver the water to the Kansas Section II account and no credit will be claimed for the unconsumed portion for this delivery.

- D. The Committee recommends that the procedures described in paragraph C above apply only to the past deficits and should remain valid only as long as this past deficits balance exists, and does not establish any precedent for any future dispute or for replenishment of transit losses on the release of water from the Kansas Section II account, subsequent to this recommendation, in any manner other than that provided for in the 1980 Operating Plan and the 2006 Agreement on Measurement of Section II Deliveries.
- E. The Committee recommends that ARCA, through its Operations Committee, conduct a review of the circumstances that led to the delivery deficits of 2002 and 2004 and to review the provisions of Section II E 5 of the 1980 Operating Plan in order to better understand the meaning of reasonable and favorable conditions under varying operational and hydrologic conditions.
- F. The issues referenced as Issues #52 (Upstream Storage during Spills) and #60 (Section II C (2) compliance, a.k.a. Agreement B) in the "Water Issues Matrix" document, <u>JMR Accounting Issues</u>, dated April 2005 have not been resolved by the Committee and those issues remain in dispute. The Committee makes no recommendation on these issues at this time, and the Committee acknowledges that Kansas does not waive any claim to past damages or restitution of water on those disputed issues.

Therefore, it is the recommendation of the Special Engineering Committee that ARCA adopt the above recommendations in their entirety, or not adopt them at all.
